Sir,

I ASI Sanjay Basunia of Matigara P.S do hereby lodge a Complaint to the effect that on 12.06.2023 at 18:30 hrs I received a information from reliable source that one vehicle Bolero Pickup bearing Reg. No. WB - 73 D 7403 loaded with stolen river bed materials coming from Ranannagar Ghat side . On receiving the information I along with available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at near Ranannagar Ghat under Matigara P.S area, I found one vehicle Bolero Pickup bearing Reg. No. WB - 73 D 7403 loaded with river bed materials going towards Matigara. Subsequently, I manage to stop the vehicle but the driver of the vehicle fled away from the area.

As such I seized the above noted loaded vehicle under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials and brought to the above noted bricks at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the seized vehicle Bolero Pickup bearing Reg. No. WB - 73 D 7403 under proper section of law and arrange for its investigation.
