Sub:- Written complaint against 01(one) ToTo Driver of plying illegally on Kachari Road at Hospital More without any valid documents causing obstruction to public way.

Sir,

I, SI Kedar Prodhan of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 12.06.23 around 19.05 hrs, while on duty at Hospital More found one (1)TOTO without any registration number stationed near Hospital More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Suman Mandal (23Yrs) S/o -Jeewan Mondal of Santi Nagar, Shil Bari More, P.S- Bhakti Nagar ,Dist- Jalpaiguri. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
