## Respected Sir,

- 1. I, Ratan Kumar Bihani, the undersigned, would like to bring to your kind notice the following facts. That I am the sole, absolute and exclusive owner in possession of all that piece or parcel of land measuring 4.79 Acres, comprised of L.R. Plot No.509, recorded in L.R. Khatian No.615, situated within Mouza Dabgram, J.L. No.2, L.R. Sheet No.2, Pargana Baikunthapur, P.S. Bhatinagar, District Jalpaiguri, having permanent, heritable and transferable right, title and interest therein and I have secured the said land by constructing a boundary wall. That I am also one of the co-owners of all that adjacent land forming part of L.R. Plot No.497 situated on the northern boundary of the aforesaid land measuring 4.79 Acres.
- 2. That in the evening of 12-06-2023, to my utter surprise, my caretaker informed me that excavation was conducted on my aforesaid land forming part of L.R. Plot No.497. Moreover, the said offences have been committed with such a malafide intention that the southern boundary wall collapses thereby hurting / causing death of person/s present near the said boundary wall which clearly draws the offence of mischief committed after preparation made for causing death or hurt under the Indian Penal Code.
  - 5. Stated this, you are hereby requested to take into consideration this written complaint and initiate necessary legal action against abovenamed Makhanlal Roy and his accomplices at the earliest for which I shall remain grateful.
