

Subject- Written complaint against Makhanlal Roy, son of Upendernath Roy, resident of Raja Ram Mohan Roy Road, Salugara, Siliguri, District - Jalpaiguri and his accomplices.

Respected Sir,

1. I, Ratan Kumar Bihani, the undersigned, would like to bring to your kind notice the following facts. That I am the sole, absolute and exclusive owner in possession of all that piece or parcel of land measuring 4.79 Acres, comprised of L.R. Plot No.509, recorded in L.R. Khatian No.615, situated within Mouza - Dabgram, J.L. No.2, L.R. Sheet No.2, Pargana - Baikunthapur, P.S. - Bhatinagar, District - Jalpaiguri, having permanent, heritable and transferable right, title and interest therein and I have secured the said land by constructing a boundary wall. That I am also one of the co-owners of all that adjacent land forming part of L.R. Plot No.497 situated on the northern boundary of the aforesaid land measuring 4.79 Acres.

2. That in the evening of 12-06-2023, to my utter surprise, my caretaker informed me that excavation was conducted on my aforesaid land forming part of L.R. Plot No.497. That on receiving the said information, my employee immediately rushed to the spot and discovered that substantial excavation and digging had been undertaken on the edge of the aforesaid boundary wall and humongous amount of earth/ soil had been removed from the said land without my knowledge or consent whatsoever. Moreover, such illegal excavation and digging has damaged and weakened the foundation and structure of the said boundary wall which may result in collapse of the said boundary wall.




3. That upon enquiring the local people, I became aware of the fact that yesterday night abovenamed miscreant - Makhanlal Roy together with his accomplices had trespassed into my aforesaid land and for their wrongful enrichment, had in the most illegal manner conducted the said excavation and digging and removal of earth/ soil without my knowledge or permission / sanction of the concerned Authority.

4. That this is to inform you that abovenamed miscreant - Makhanlal Roy and his accomplices have not only committed the offence of criminal trespass with an intent to intimidate, insult and annoy me and to destroy and damage my property but have also violated the provisions of the West Bengal Land Reforms Act. Moreover, the said offences have been committed with such a malafide intention that the southern boundary wall collapses thereby hurting / causing death of person/s present near the said boundary wall which clearly draws the offence of mischief committed after preparation made for causing death or hurt under the Indian Penal Code.

5. Stated this, you are hereby requested to take into consideration this written complaint and initiate necessary legal action against abovenamed Makhanlal Roy and his accomplices at the earliest for which I shall remain grateful.
