Sir,

In producing herewith one arrested accused person namely Bipen Kumar Sahani (23 yrs) S/O- Rajendra Sahani of Ward No. 06, Jorpura, PS- Tazpur, Dist- Samistipur, Bihar 848504, A/P- Adarsha Nagar, Ward no. 04, P.S- Siliguri, Dist- Darjeeling along with seized articles Viz- one TOTO without number plate and loaded 42 (Forty two) numbers of Water pump in 20 packets, each containing 02 pieces and 02 packet, each containing 01 pice.

I beg to report that, I ASI(UB)/40 Indrajit Das S/O- Sri Baidya Nath Das now posted at Bhaktinagar Traffic Guard under Siliguri Police Commissionerate, lodge a written complaint against the above noted TOTO driver, to the effect that, on 12.06.2023 at 18:15 hrs in course of performing traffic duty at 2 ½ mile Checkpost More, P.S- Bhaktinagar, Dist- Jalpaiguri along with C/961 Kamal Chandra Mallick, C/1177 Dharendra Dahal both of Bhaktinagar Traffic Guard, SPC, vide Bhaktinagar Traffic Guard GDE No. 141 dated 12.06.2023, found that the above noted person riding his TOTO without number dangerously Bhaktinagar Check Post, on National Highway-10, loaded with above noted goods causing hindrance and danger to the general public and others vehicle.

On being asked, the above noted driver disclosed his name and identity as noted above. On demand, he failed to produce any papers/documents in support of the above noted TOTO & articles. Accordingly, I detained the said TOTO and arrested him u/s- 41 Cr.P.C and seized the articles noted above under proper seizure list in presence of witnesses after observing all rules and formalities.

Hence, I pray before you that a specific case may kindly be started against the above noted accused TOTO driver under proper Section of Law.
