Chaupukuria, P.S. Bagdogra, Dist. Darjeeling 734 017 have been repeatedly trying to grab our hatbazar comprised within the leasehold land of our tea

estate and trying to instigate land brokers and mafias to make permanent structures / shops in our hatbazar leasehold land with the intention to oust the garden management.

We have also learnt that the said outsiders have also proposed to some land brokers and mafias for transfer of shops in the hatbazar in exchange of monies for their illegal gains. Earlier also the Sri Pradhunya Mandal along with his antisocial associates had illegal erected a flag in our hat bazar leasehold land illegally claiming that the land belongs to the shopkeepers of the hat. Such incident was brought to your knowledge vide the above referred complaint dated 09.11.2022 and thereafter the flag was removed at our end. There is a atmosphere of panic and anxiety amongst our workers who are in fear that our hat bazaar shall be illegally occupied by said land grabbers and scrupulous miscreants thereby converting it into their private property due to which the workers shall be deprived of the bazaar which is a leasehold land of the garden and primarily used by the workers, their family member and dependants.

It is very much evident and established from the aforesaid Mass Petition submitted by our workers that the said 1) Sri Pradhunya Mandal S/o Late Nidhir Mandal and 2) Sri Rabindra Basak S/o Gaishal Lal Basak and others who are not the workers or in any way connected with the garden have conspired grab our hat bazar leasehold land for their own illegal motives and gains and as such we request your good office to take immediate action / steps against the said miscreants to protect our kestapur hat bazar leasehold land so that no illegal transfer or interest is created nor any illegal structures / shops are erected by the miscreants which may disturb the peaceful possession of the garden management over and upon its hat bazar lease land and the workers are deprived of the bazaar.
