Respected Sir,

I, ASI Chandra Mohan Barman, of Bagdogra Traffic Guard, SPC, presently conducting the Traffic Regulation duty at Bihar more under Bagdogra Traffic Guard, beg to lodge a written complaint that on 09.06.23 around 06:40 pm 01(one) toto vehicle without any registered number is coming from Arjunpath air force side carrying 06 passengers, on Service Road, near Rajdeep Guest House the said toto over turned due to rash driving of toto driver, 03 passenger were severely injured, out of them 02 passenger were released from Bagdogra primary Health Center after giving them first aid treatment. 01 Lady Passenger were referred to North Bengal Medical College for her leg injury treatment from BPHC. According to an eye witness the Bihar more Bound said toto was running at high speed, suddenly, 02 nos of Dog came in front of the Toto from the opposite direction. In order to save the Dog, the toto drivers suddenly press the break and lost the control as a result over turned the toto.

According to ASI Chandra Mohan Barman of Bagdogra Traffic Guard, along with CV 739 Bikash Nagasia of BDR TG had been present at Bihar More accident place. After some time disclosed the toto driver name as Samit Das, (Age-25 yrs), S/O- Kalipada Das, employee of Officer Mess, Air force Officers Mess AFS Bagdogra. Accused toto driver fled away from the Spot.

Accordingly, I seized the toto after preparing proper seizure list in presence of witness. Therefore, I request you kindly take action against the said toto driver as per law.
