Sir,

I, SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing two arrested accused persons namely (1) Ishak Beck (23), S/o Sanjit Beck and (2) Patrash Oraon (23) S/o Lt. Rajesh Oraon both of Tirrahana Tea Estate, Bara Line PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Forty (40) nos of sealed Bottles of Galaxy 70 up OYE OYE, each bottle 300 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.
2. Eight (08) nos of sealed Bottles of Kingfisher strong premium beer, each bottle 650ml, Marked as Exhibit-B from which 01 bottles taken as sample for examination Marked as Exhibit-B1.
3. Six (06) nos of sealed Bottles of emboss Fine whisky, each bottle 750ml, Marked as Exhibit-C from which 01 bottles taken as sample for examination Marked as Exhibit-C1.
4. One blue colour Honda Activa Scooty 125 having regd. No. WB-72-R-1096

I am submitting a written complaint against the above noted two accused persons to the effect that today on 11.06.23 at 16-15 hrs Myself along with C/851 Chandan Debnath, CV- 386 Kishor Hawlder, CV-375 Jogesh Barman VP-01 Ansalam Kujur left for performing Special evening Mobile duty vide Bagdogra PS GDE No. 630 dt. 11.06.23. At 16-25 hrs received a secrete source of information that two persons were standing with a Scooty at M.M. Tarai and selling Id Liquor illegally to its customers who were coming for visit M.M. Tarai Picnic Spot without any valid license. Accordingly I informed the matter to O.C.*Bagdogra PS and as per his instruction myself along with and force left for M.M. Tarai to verify the veracity of information. On arrival at the spot at 16-55 hrs it was found that two persons were sitting in a Scooty and selling liquor to their designated customers illegally in lieu of huge money. On seeing the police party they tried to flee away, but we apprehended the said two persons with Scooty bearing No. WB-72-R-1096. On being asked they disclosed their name and address mentioned above. Thereafter in presence of disinterested witnesses namely (1) Diwash Dutraj (42) S/o Kumar Dutraj and (2) Ujjal Sharma (32) S/o Lt. Prakash Sharma both of Daragaon, sukantanagar PS Bagdogra Dist. Darjeeling I recovered above mentioned articles from their possession which were kept in a nylon bag in the said Scooty, on asked they failed to produce any documents / license in support of the same, accordingly I seized the all recovered articles from the possession of the above noted apprehended persons as per proper seizure List and labeled duly signed by them and also witnesses. On further interrogation they confessed their guilt. As such I arrested the above noted two accused persons u/s 41 Cr.P.C as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 17-05 hrs and 17-45 hrs (seizure Total approx 21.7 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against two arrested persons namely (1) Ishak Beck (23), S/o Sanjit Beck and (2) Patrash Oraon (23) S/o Lt. Rajesh Oraon both of Tirrahana Tea Estate, Bara Line PS Bagdogra Dist. Darjeeling and arrange for its investigation.
