Sir/Madam,

With due respect, I, Smt Debasmita Mitra nee De, W/o Sri Abhishek Mitra of Ashrampara, Jatin Das Sarani, P.O - Siliguri, P.S - Pani Tanki Out Post Dist - Darjeeling would like to inform you that myself along with my husband Sri Abhishek Mitra and Friends namely Barnali Das, Rahul Paul, Srinwanti Dey, went to Rurban Village Resort situated at Dhukuria, Joradighi More, Patharghata -734010, P.S- Matigara, Dist- Darjeeling to spend some leisure time. We have a one day Booking in the name of Srinwanti Dey on 10/06/2023 and Check out on 11/06/2023 at 11.00 am. We entered into the said Resort approximately 6.30 pm. on 10/06/23 & thereafter my other friends came and we started to spend good quality time in and around the Resort pool. At around 12 am the Manager of the said Resort namely Sri Arindam Sengupta suddenly on drunken condition came to us and told us to leave the pool or else he will call the police and over the issue a scuffle ensued between us and the management of the said Resort. Suddenly a group of hooligans numbering about 10 assembled by the Manager of the said Resort namely Sri Arindam Sengupta started to physically assaulted my husband Sri Abhishek Mitra with belt as a result of which he was profusely bleeding from his ear and his spectacle was broken and they also assaulted him with fists & blows. They also tried to snatch his gold chain from his neck and was able to snatch the marking of the chain styled as "S" made of gold which weighted may be of 2 to 3 grams. When I tried to resist them from doing so they also physically assaulted me and tried to outrage my modesty by pushing me from the front as well as from the back side & I also fall down into the floor. Then we called 100 Dial and officers of Matigara PS came to the spot and in their presence we checked out from the said Resort at about 1.00 am and went to Siliguri District Hospital for medical treatment where we have been medically examined and my husband got stitched on his left ear. Then on 11/06/2023 at about 1.00 - 1.30 pm. the owner of the said Resort called us & we narrated such horrible incident to him but he was least bothered to hear about our grievances rather indirectly cautioned us not to approach to any authority.

It is also important mention that I also got medically examined and got dressing in my backside and had abrasion mark in my left thigh but unfortunately I lost my OPD Ticket because of such strain and terror accompanying violent crimes. We are in such mental trauma and was so anxious about our physical state of mind that there was some delay in lodging this complaint. So Sir, I shall be highly obliged if you kindly take necessary legal steps in this regards against the above named culprits and their associates & do the needful accordingly.
