under Islamic law & custom, on dt. 25.11.2019,
with Md. Siraj S/O Md. Hakim of Khalai Bakhtai,
Talsi Nigam, P.O & P.S. - Mutigara, BWH - Bujebury,
But even after the birth of my daughter on dt. 25.09.20
when my said husband & his relatives noted above
did not stopped subjecting me for physical & mental
Cruelty for demand of dowry than I lodged a
written complain against them at Mutigara Police
Station on dt. 01.08.2021 and over the said complain
started, Mutigara P.S. case no. 798 of 2021, u/s 498A
& IPC, R/w Sec. 3 & 4 of D.P. Act, which is still
pending at Siliguri Court.

Later on after a sulisi Satta, my father had to
given them legal expense in this said case and
then my said husband & his relatives allowed me
to enter into my matrimonial house.

That on dt. 01.01.2023, I left my matrimonial
home with my minor daughter when my said husband
& his relatives noted above, beaten me brutally &
drove me from my matrimonial house, & since then
I am staying at the home of my parents.

Recently I came to know that my said husband
have solemnized his re-marriage with another
girl, without giving me divorce & during my lifetime.

So, please take necessary action against my
husband & his relatives noted above.
