1. It is informed that I am a combatant member of Indian Air Force and present posted to 2407 Sqn C/G Air Force Station Bagdogra. On 16 Jun 23 at about 0630 hrs, my house owner informed me that lock of main iron gate is missing and my bike is not available in the parking area. I came down to parking area and found that my motor bike (Bajaj Pulsar 180 CC Blue) having registration number TS07 EF 3860, Chassis number MD2A1202731403439 and Engine Number DJZC6G60401 is missing from my rented residence parking. The lock of main Gate was also found missing. I searched it in nearby area but could not be traced out. The said bike was last seen by me at 2200 hrs on 15 Jun 23 before going to bed. The lock of main gate was properly locked and handle lock of bike was also locked. The bike is registered in the name of my son named Nitin Kumar.
