Respected Sir,


I, Mamta Gupta, wife of Sri Bikram Gupta, resident of Netaji Nagar near Lord Shiva Temple, Champasari, Police Station Pradhan Nagar, District Darjeeling, would like to state that Raja Prasad @ Sanjit Gupta, Ranjan Prasad, Deepak Gupta, all are sons of Gupteshwar Prasad, Jitendra Prasad, Gupteshwar Prasad, both are sons of Sri Satyanarayan Gupta and wife of Gupteshwar Prasad is our neighbor and our house is adjacent to each other. That our said neighbor have constructed their building in such a way that in the rainy season the water is used to dripping from the roof and fall on our house as such 15 days ago my parents have requested them to repair their roof so that the water will not fall in our house in near future but they are stubborn in nature had quarrel with my family members and also beat them with feast and blows, the said incident is/was captured in our CCTV installed in front of our house, however being a respectable person of society we short out the matter and did not lodged any complaint against them as they promised that they will repair the same soon. That today at about 12.30 p.m. I told them that the water is dripping from their roof and is

falling in our house as such requested them to repair it as soon as possible but said Raja Prasad @ Sanjit Gupta, Ranjan Prasad, Deepak Gupta came forward and heat me with slipper and dragged me by pulling my hair inside ^{my} their house, tore by blouse and tried to disrobe me with an intention to rape me but hearing my hue and cry when my brother Binay Kumar Gupta and his wife Sneha Gupta came to rescue me in their hands said Ranjan Prasad, Sanjit Gupta hit in the stomach of my brother's wife Sneha Gupta with wooden battam who sustain a serious injury, and said Gupteshwar Prasad, Jitendra Prasad hit my brother Binay Kumar Gupta with wooden Battam as a result my brother's wife and my brother fell down and they mercilessly beat both of them with fist and blows, as such my father Bal Govind Gupta came to rescue us but the said miscreants beat my father in his eye and as a result he also sustain a severe injury, however thereafter the lady member of the said family were using filthy languages and continuously instigated the said miscreants to rape me and my brother's wife Sneha Gupta and kill both of us. That upon their instigation they tore our blouse, saree and tried to rape us but with the help of the other family member we were able to resist them. That as all of us sustain serious severe injury we rushed to the Siliguri District Hospital where our treatment is going on.

Under the above circumstances I hereby lodging this complaint against the abovenamed wrongdoer and would request you to kindly investigate the matter and do the needful as soon as possible in this regard so that wrongdoer can be punished as per the procedure established by law.
