Sir,

With due respect, I, Saraswati Sarkar, Wife of Late Shibu Sarkar, Resident of 207 Patiramjote, VTC: Patiram, P.O. Matigara, Dist- Darjeeling, Pin- 734010, beg to inform you that I am widow lady working as a maid servant so that I could provide for my family which includes my two children.

Today i.e. on 20/06/2023, at about 5 p.m., when I returned home from my work, I found that the lock of my room was broken and on searching I found that one drilling machine which was present in my house was also missing and due to which I started hue and cry regarding the same. At the very moment, my brother-in-law namely Narayan Sarkar came and entered into house and when I asked him about the incident he rushed toward me with an iron rod and told me that he had broken the said lock and taken the said drilling machine and when I asked about the reason of doing so, he abusive me with filthy slang languages and he pushed me to fall down and started assaulting me with fist, kick and with the said iron rod therefore I brutally injured and my wrist was cut and bleeding profusely and I feel unbearable and tremendous pain and then further even tear down my blouse with an intention to rape me but I somehow pushed him away and flew away from the said place. Due to the same, I received injured on my right hand, head, ear, chest, neck, spine, thigh and had to take medical treatment from Matigara Hospital.

This is pertinent to mention here that I and my two children are facing tremendous insecurity regarding life and property.

Under the above circumstances I am seeking your help and needful action regarding the said matter and provide me the necessary legal assistance in this regard. Therefore you are requested to take proper legal action against
