Darjeeling, would like to inform you that on 07.03.2020, one Hindu Marriage was solemnized between me and a person namely Sri. Abhishek Ray, S/o. Sri. Niranjan Roy, R/o. Sahebkachari, Para-1, Balurghat, South Dinajpur, West Bengal, as per Hindu Rites and customs at Maa Bhawani Kali Bari, Bidhan Market, Siliguri and during that time my as well as his family members were also presence and after the aforesaid marriage, I went to my matrimonial house and started to live there with my husband as a huband and wife and it is also important to mention here that out of the said wedlock one Male child also born on 08.04.2021 namely Aditya Ray.

It is important mention here that after 4-5 months of my marriage I noticed that my above named husband coming home late night in drunken condition and after coming to home used to abuse me by using filthy languages and also started to doubt my character and tortured/harrased me physically and mentally, not even that he also abused my father, Moreover, when I narrated the incidents to my father-in-law namely, Sri. Niranjan Roy and my mother-in-law namely, Smt. Pompa Shil Roy, they also thrashed me with fist and blows and told me that if I complain this to anyone even to my family memebers then all of them will kill me, however, I tolarated the same because at that time I was pregnant and I thought that they will change their behaviour after the baby is born, but nothing changed even after giving birth, they kept on torturing me and it is important to mention here that after the baby was born, he neglected to provide proper food or clothes to me and my aforesaid male child but I tolarated all those in-human torture of my husband and my in-laws with a hope in my mind that one day they will change but such day never come to our life.

It is pertinent to mention here that when I told him that I will leave him and will reside in my parent's house then he became more ferocious and assaulted me with fist and blows, Utlimately, on 17.06.2023, when I went to my Grandmother's home in Guptipara, P.S. Balagar, Dist. Hooghly, with my son to meet her, at around at 01:30 pm, when I was sleeping at that time my husband suddenly came to my Grandmother's home and with the help of pillow he pressed my mouth because of which I could not breathe properly and he tried to kill me by the aforesaid way and ultimately with the mercy of God and with the help of people around I saved myself from his hand and some how I took shelter at my parental house above noted but still he and my in-laws over telephone threatening me with dire consequences, right now I am spending my days in fear So, finding no other alternative way today with help of my well wishers I lodged this Written Complaint before you against the above named persons.

Therefore I request you to kindly take necessary legal action against the above named persons and save me from their hands as early as possible.
