In producing herewith one arrested accused person namely Ratan Sarkar(45yrs) S/o. Lt. Rajendra Nath Sarkar of Jamurivita, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 18(Eighteen) sealed bottles of Himalayan Gold 60 UP Country Sprit containing 600 ML each.
2. One Nylon Bag.

I ASI Rana Jadav of Ambari Falakata Out Post under NJP PS/SPC lodged a written complaint against the above noted person to the effect that today on 21.06.2023 at 16:45 hrs received a source information from Sahudangi Hat, under Ambari Falakata OP that the above noted person has gathered huge amount of liquor illegally at Sahudangi Hat area for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE No. BB7 dated 21.06.23 I informed to O/C Ambari Falakata Out Post about the information. As per his kind instruction I along with, (1) C/-B24 Satyaban Das and (2) NVP-24 Kiran Roy both of Ambari-Falakata OP, Under NJP PS/SPC proceed to Sahudangi Hat under Ambari-Falakata OP to work out the information. At 17:05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Sahudangi Hat area and recovered the above noted articles from the possession of accused person namely Ratan Sarkar (45yrs) S/o. Lt. Rajendra Nath Sarkar of Jamurivita, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person in presence of witnesses namely (1) Abhijit Majumder S/o. Lt. Ashim Majumder of Mahamaya Colony, PO. Kamaryita, PS. NJP, Dist-Jalpaiguri and (2) Subash Sarkar S/o. Lt. Narayan Sarkar of 09 No. Colony, PO. Kamaryita, PS. NJP, Dist-Jalpaiguri. The seizure was made between 17:25 hrs to 17:45 hrs. Then I arrested the said person u/s 41 Cr P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Ratan Sarkar(45yrs) S/o. Lt. Rajendra Nath Sarkar of Jamurivita, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri under proper section of law.
