With due respect, I am producing herewith 01 (one) arrested accused person namely Jhantu Sarkar_30yrs) S/o Gouranga Sarkar Of Michle madhusudan colony, Near Sitala Mandir, PS- New Jalpaiguri, Dist.-Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 10 (Ten) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.)
2. 15 (fifteen) bottles of FATA FATI 70 Up spirit (each bottle containing 300 ml in each bottle)
3. 10(ten) bottles of KACHI 70 UP Spirit (each bottle containing 300 ml in each bottle)

I, SI- Pradip Diyali presently attached with NJP PS under your kind control beg to state that on 22.06.2023 at 07.25 hrs I received a secret source information that one person namely Jhantu Sarkar_30yrs) S/o Gouranga Sarkar Of Michle madhusudan colony, Near Sitala mandir, PS- New Jalpaiguri, Dist.-Jalpaiguri is selling ID liquor illegally at Swasan para, under New Jalpaiguri, Dist.-Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 1088 date: 22.06.2023 and informed the fact to you. As per your kind direction and instruction myself along with ASI-Kagen Barman C/1044 Hari Kherwar, C/453 Uttam Dey all of NJP PS, SPC left for Swasan par, PS- New Jalpaiguri, Dist.- Jalpaiguri to work out the information in hand. At 20 ,05 hrs we arrived at the shop of Jhantu Sarkar_30yrs) S/o Gouranga Sarkar Of Michle madhusudan colony, Near Sitala mandir, PS- New Jalpaiguri, Dist.-Jalpaiguri and being identified by the source I held raid at the shop of Jhantu Sarkar_30yrs) S/o Gouranga Sarkar Of Michle madhusudan colony, Near Sitala mandir, PS- New Jalpaiguri, Dist.-Jalpaiguri .where the above noted accused person selling ID Liquior. Accordingly as per the indication of Source I managed to apprehended him. During raid the persons who were taking liquor was able to fled away from the spot. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 08:05 hrs to 08:25 hrs on 22.06.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Jhantu Sarkar_30yrs) S/o Gouranga Sarkar Of Michle madhusudan colony, Near Sitala mandir, PS- New Jalpaiguri, Dist.-Jalpaiguri and arrange for its investigation.
