Subject: A complaint against the Husband and in laws for torturing mentally and physically.

Respected / Sir,

I, Smt. Shibani Chakraborty, W/O Sri. Babul Chakraborty, D/O Late Anil Chakraborty, resident of Deshbandu Colony, Siliguri Pipe Line Road, S.M.C. P.O- Siliguri Town, & P.S- Siliguri, Dist- Darjeeling, Pin – 734004, would like to inform you as follows:-

- 1) That my marriage was solemnized on 24<sup>th</sup> February, 2012, at Deshbandu Para with one Babul Chakraborty, S/O Jotish Chakraborty, resident of Sahid Colony, Netaji Subhash Road, Bhaktinagar, P.O- Bhaktinagar, P.S- N.J.P, District – Jalpaiguri, but within a span of two to three months my husband and in laws started torturing me and my husband always come home in a drunken condition but being a newly married women I used to tolerate with a hope that he will correct himself in coming days, but all in vein my in-laws regularly threatened and asked for Dowry from my widow mother even though my mother had pain Rs. 20,000/- at the time of marriage as demanded by my husband.
- 2) That on the second day of marriage all my ornaments (stridhan) 1. Necklace, 2. Ear ring 3, bangle 4. One ring had taken by my in laws namely Mira Chakraborty, and whenever I asked regarding my jewellers she simply denied to handover the same to me. Since the day of marriage I had maintain myself with the aid of my mother as because my husband never paid me single penny for household expenses, at the time of marriage my mother had given me (stridhan properties) 1. Armirah, 2. Alna steel, 3. Steel bed (along with quilt and pillow), 4. Utensils, 5. One Bicycle, 6. Sewing machine, 7. Gas, all is in the custody of my husband including its original receipt.

- 3) That my husband had always asked money from my mother (Widow) my mother being a loyal women, and for sake of me had paid partly more than 1,00000/- but my husband had never changed himself even after getting money from my mother had several times torture and mercilessly beaten to me in each and every occasion , my in laws had always scolded me and never allowed me to have healthy food.
- 4) That thereafter the level of mental torture raised to an extreme level I was unable to bring dowry from my parents and as a result I was physically harassed/tortured by my in laws as well as by my husband, but with a view to continue my marital life, I tried to settle and never complained before any authority against my husband and in laws but all in vein.
- 5) That on 10/06/2023 my husband and in laws started to threat me saying that they will sell all the stridhan properties and also pressurised me to sign some blank papers, when I refused to do the same my in laws and my husband closed the main door and confined me in a single room and all my in laws and husband beat me with fist and blows and also tried to strangulate my neck, and thrown me out of my marital house thereafter anyhow I had managed to inform my mother therefore Due to mental and physical assault I was not in a condition to attain Police Station and that is the reason of delay to file this complaint/F.I.R .

That I pray before your authority to take necessary legal steps just to secure my life and get my Stridhan properties and investigate the matter and punish the guilty persons.
