Sir,

In producing herewith one accused person namely Kripasindhu Roy (27 yrs), s/o - Kamal Chandra Roy of Baruapara, PS - Rajganj, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 15 (fifteen) sealed bottles of Himalayan Gold 60 up Country Spirit each bottle containing 600 ML.
2. One nylon bag.

I, ASI. Kajal Chakraborty of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 22.06.2023 at 18:25 hrs received source information from Sitaguri that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 832, dated 22.06.23. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with ASI Rana Jadav, ASI Sk. Tinku C/975 - Swarup Basak all of Ambari-Falakata OP, Under NJP PS/SPC proceed to Sitaguri to work out the information. At 18:55 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Sitaguri area and recovered the above noted articles from the possession of accused person namely Kripasindhu Roy (27 yrs), s/o - Kamal Chandra Roy of Baruapara, PS - Rajganj, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Tarzen Roy, s/o - Narma Roy of 9 No Colony, PS-NJP Dist- Jalpaiguri and 2) Baban Prasad, s/o - Sohan Prasad of -Do-. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 19:25 hrs to 19:35 hrs. Then I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Kripasindhu Roy (27 yrs), s/o - Kamal Chandra Roy of Baruapara, PS - Rajganj, Dist- Jalpaiguri under proper section of law.
