I, Smt. Sunita Sharma W/O Shri Gagan Singh Sharma, resident of near Panighatta Road, Opposite of Gupta Flour Mill, Upper Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, beg to report you the following facts for your kind information and necessary action please.

That yesterday on 17.06.2023 I, along with some of my friends including Anand Kujur S/O late Alexius Kujur of Vivekananda Pally, Upper Bagdogra went to Bengdubi forest to fetch dry fire woods to cook food when LPG is exhausted and at about 5.00 pm I was tightening the bundle of small dry fire woods near Bhanga pool Bengdubi in the mean time altercation arose between me and Anand Kujur regarding tightening of the bundle of fire woods and suddenly he snatched a Kodali from a person standing near to us and hit me with it targeting on my head but luckily I saved myself and the hit fell on my left hand as a result, I got cut injury on my left hand near elbow. I am a low pressure patient and due to much bleeding I could not even stand and I could not go to hospital or Police Station instantly and today morning I went to Bagdogra Hospital where I have been treated.

Sir, I, therefore, request you to enter this report in the G.D.E. maintained by you and take necessary action against person complained for and for that act of kindness, I shall remain highly obliged to you.
