Sir,

I ASI Dindayal Mandal of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 24.06.23 around 18.45 hrs, while on duty at Sevoke More , Hill Cart Road area found one TOTO without any registration number stationed near Sevoke more, Hill Cart Road in such a way blocking the free flow of traffic and causing hindrance and danger to the general and other vehicles.

Accordingly I detained said TOTO and on being asked the driver disclosed his identity as Rajesh Sahani (M-8158084592)S/O- Kamal Deb Sahani of Chittaranjan Colony, W.No-20,P.S- Siliguri , Dist- Darjeeling . Further on being asked to produce relevant documents in support of his claim of plying TOTO on Major Road he failed to produce any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
