Respected Sir,

Most humbly and respectfully, I, **Smt. Shunu Sarkar**, Wife of Sri Ajay Singh and Daughter of Bhim Sarkar, presently residing at Durgaguri, Ward No. 45 of S.M.C., Near Radhakrishna Mandir, P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, in the state of West Bengal, beg to state that I have entered into marriage with **Sri Ajay Singh**, Son of Late Gopal Singh of Ratanlal Busty, Ward No. 01 of S.M.C., P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling on 07.03.2015 as per Hindu Rites and Customs and after marriage, I along with my husband started to reside at my in-laws house at Ratanlal Busty, Ward No. 01 of S.M.C., P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling and out of our said wedlock, a male child was born on 05.10.2016 namely Avimanyu Singh.

That after few months of marriage, my husband and his mother Smt. Sunita Devi started unbearable torture upon me without any rhyme and reason, not only that they used to assault me physically and asked me to bring money from my parents.

That after elapse of few months day by day, my husband along with his mother and others used to assault me by fists and blows even with lathi inside the lock room.

That finding no other alternative in the year of 2017, I have lodged a written complaint to the Siliguri Women Police Station against my husband and his mother and on the basis of the said complaint, the Siliguri Women Police Station started a specific case U/S. 498A of I.P.C. and the said case is pending.

That I was/am ready to lead a happy conjugal life with my husband but I am now very much apprehensive of my life due to illegal demand and torture by my husband and his family members.

That in the month of 10.09.2021, my husband and his mother physically assaulted me mercilessly and finding no other alternative, I came at my parental house with my minor son at Durgaguri, Pradhan Nagar, Siliguri, Dist. Darjeeling but my husband and his other family members kept my stridhan properties forcibly.

That on 14.11.2021 at about 12:30 p.m., my husband came to the house of my father and threatened me with dire consequences and also told that he will take my son forcibly.

That thereafter, I have lodged a written complaint to you by stating the above facts and I have also filed an application under Section 23 of the Protection of Women from Domestic Violence Act, 2005 before the Ld. J.M., 3rd Court being Misc. Case No. 16/2023 (Filing No. 3885817/2022) and the said case is pending. I have also filed an application U/S. 125 of Cr.P.C. before the Ld. J.M., 3rd Court being M.R. Case No. 16/2023 (Filing No. 3885816/2022) and the said case is also pending.

That suddenly on 12.06.2023 at about 4:00 p.m., my husband saw me at Champasari Tower Galli when I was going towards Champasari for shopping and attacked me and assaulted me physically on my face and backbone by sharpen weapon with an intention to kill me and for which, I sustained grievous injury on my spinal code and also bleeding injury.

That thereafter, I shouted for help and my husband escaped from that place and thereafter, I was treated by the doctor at Siliguri District Hospital and I am now under treatment.

So, I therefore, request you to take necessary legal action against my husband Sri Ajay Singh. And for this act of kindness, I shall be much obliged to you.
