I PSI Koushik Raha s/o Jitendra Raha of Bhaktinagar Police Station, under Siliguri Police Commissionerate after producing two arrested accused persons namely (1) Bikash Mallick-25yrs s/o Lt Hira Mallick of Dasarathpally, Near TB Hospital ward no-44, and (2) Sourav Kumar Dasarathpally ward No-44 of SMC PS Bhaktinagar Dist Jalpaiguri Das-34yrs s/o Lt Mukunda Das of South station para, PO+PS Naxalbari at present C/o Sripoti Paul of Gitalpara near Alamin lady's hostel Haiderpara, ward no-40, PS Bhaktinagar Dist Jalpaiguri along with seizure articles (1) 60 (sixty) pieces of Vials of LUPIGESIC INJECTION each vial containing 02 ML (1) 60 (sixty) Vials of DIAZEPAM INJECTION each vial containing 02 ML (2) 55 (Fifty five) Vials of PHENERGAN INJECTION each vial containing 02 ML (4) One Honda Grazia scooty bearing No-WB74BB/7582 and (5) one real me mobile phone do hereby lodged written complaint to the effect that on 23.06.23 at 21.15 hrs received reliable source information that two persons were standing at Pranami Mandir road, near Haiderpara Market complex, in front of NANDAN Apartment with one scooty loaded with huge Prohibited injections in their possession to deliver the same to someone. It is reasonably believe that the persons possessing the Injection may escape from the scene if Police party did not reach the spot immediately. The information was reduced in writing vide Bhaktinagar Police Station GDE no. 1117 dated 23.06.23 and informed superiors about the plan of action. Thereafter myself along with SI Srimanta Chatterjee, SI Mrinal Basunia, SI Rantu Halder, ASI Dipak Karmakar, C/1430 Dilip Barman, C/915 Chandra Prakash Adhikary after taking blank paper, wax, metal seal and knife and other investigation kits left for the PO to work out the information vide Bhaktinagar PS GDE No-1118 dated 23.06.23 & MCC No.890/23 dated 23.06.23.

At 21.50 hours I along with officer and force reached at Pranami mandir road, in front of Nandan Apartment, Near Market complex and contacted the source who show us the persons from a certain distance, I briefed all Officers and force to cordon the persons as tactful as possible in order to thwart their escape from the scene. Meanwhile I called two independent witnesses namely 1) Dipeck Singh-35yrs (Ph-7679865069) s/o Lt Mohan Singh of Haiderpara, Bhola chowhan road, ward No-40, PS Bhaktinagar Dist Jalpaiguri and (2) Md Appu-26yrs (ph-8101942334) s/o Lt Md Mustakin of Haiderpara, Asrafnagar ward No-40, PS Bhaktinagar Dist Jalpaiguri after apprising them about the information received requested them in written to remain present with us during search and seizure and also called one Videographer namely Netai Chowdhury of Haiderpara, Shivarampally, ward No-40, PS -Bhaktinagar Dist Jalpaiguri with a request to record the whole process. We rounded them up and questioned about name and address when they disclosed their identity as above. On interrogation about the drugs, initially they did not disclose anything about this. I forced them, and then they disclosed that the injections belong to them which were kept in dickey of their scooty. On further interrogation they disclosed that they procured the illegal injections to deliver the same to another person. Then I detained them and gave an option in writing whether they are willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return they given written reply that they are willing to be searched in presence of Magistrate. Then I informed Sri Manish Yadav, Assistant Commissioner of Police, (Investigation unit) SPC as Special Executive Magistrate to come at the PO as he has been detailed as SPL Magistrate also requested him to presence during search and seizure of the injections.

At 22.20 hrs Sri Manish Yadav, Assistant Commissioner of Police, (Investigation unit) SPC arrived at spot. Thereafter I opened the dickey of their scooty and found illegal injections

inside. I asked the accused persons above named to produce document if any in support of possessing such a huge quantity of injections with them but they failed to produce any document. I seized the following articles under proper seizure list in presence of witness under direct supervision of Sri Manish Yadav, Assistant Commissioner of Police, (Investigation unit) SPC under proper labeling from the join possession of accused persons.

NATURE OF ARTICLES SEIZED

- 1) 60 (sixty) pcs of Vials of LUPIGESIC INJECTION composition with Buprenorphine hydrochloride-1P equivalent to Buprenorphine 0.3Mg each vial containing 02 ML (Total-180 mg) and marked as Exhibit-A
- 2) 55 (Fifty five) pcs of Vials of promethazine hydrochloride PHENERGAN INJECTION which composition with hydrochloride-1P 25mg, each vial containing 02 ML (Total-1.375mg) marked as Exhibit-B
- 3) 60 (sixty) pcs of Vials of DIAZEPAM INJECTION composition with Diazepam 1P 5 mg, each vial containing 02 ML (Total-300mg) marked as Exhibit-C
- 4) One Honda Grazia scooty bearing No-WB74BB/7582
- No-863510053093617/03 having IMEI phone mobile me 5) one 863510053093609/03

(Seizure was made in between on 23.06.23 in between 22.40 hrs to 23.45 hrs)

Under the above circumstances it is evident that the accused persons above named procured have committing offence under NDPS act. On interrogation accused persons confessed their guilt and stated that they are doing such kind of business illegally with any valid documents/License since long for their wrongful gain. It is crystal clear that the accused persons are peddling prescription drugs meant for the sick people to cater to the need of drugs abusers in the locality illegally which has become menace to the life of the young generation and perishing the home of thousand parents. All the seized contents Psychotropic substance and falls under NDPS act. I arrested them u/s 41 Cr.P.C. after explaining them about the ground of arrest issuing proper meme of arrest. Arrested accused persons along with seized articles brought to PS, seizure list and seized articles handed over to Malkhana dealing Officer under intimation to I.C. PS for keeping record in PS property register.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused persons namely (1) Bikash Mallick-25yrs s/o Lt Hira Mallick of Dasarathpally, Near TB Hospital ward no-44, Dasarathpally ward No-44 of SMC PS Bhaktinagar Dist Jalpaiguri and (2) Sourav Kumar Das-34yrs s/o Lt Mukunda Das of South station para PO+PS Naxalbari at present C/o Sripoti Paul of Gitalparanear Alamin ladys hostel Haiderpara ward no-40 PS Bhaktinagar Dist Jalpaiguri also arrange for its investigation.
