Jalpaiguri, would like to inform you that on 21/06/2023 at about 09:30 pm, my son namely, **Vikash Gupta** without any reasons he came in front of my house and after that he used some slang lanugaes in respect of me and my family memebers and when I protested the same at that time he started to assaulted me with fist and blows and intentionally tried to kill me by way of pressing my neck during that time after listening hue and cry my minor son namely, Suraj Kumar Gupta, and my husband came to the spot and tried to rescue me from his hands but during that period the above named person became more ferocious and started to assaulted me and due to assaulted by the above named person, me and my husband sustained multiple injuries on our whole body and thereafter me and my husband treated at Siliguri Sadar Hospital and it is also important to mention here that at the time of said incidents he also intentionally outrage my modesty in presence of local people and at the time when he left the place he also threatened us with dire consequences and also told us that if we lodge any complaint before any authority then he will kill us within 3days and right now we spend our time in fear.

So, no other alternative way today I knock your door against him.

Therefore, I request you be pleased to drawn you kind attention and take necessary legal actions against him as early as possible.


