In producing here with the accused person namely Bijoy Mahato (22 yrs) S/o Lt. Jagdish Mahato of Lower Bhanu Nagar, Near Silicon Plaza, PS- Bhaktinagar, Dist. Jalpaiguri under arrest along with following seized articles:-

- 2. 06 (Six) bottles of Hayward 5000 strong beer (each bottle containing 650 ml)

I, ASI Dipak Karmakr of Bhaktinagar PS, SPC do here by lodged a written complaint against the above noted arrested accused person that on 24/06/23 at 21.52 hrs vide GDE No- 1169 received a specific input from the source that the above noted person has kept huge numbers of illicit liquor at his house. Accordingly the fact is informed to I/C Bhaktinagar PS. As per his direction I along with Const-915 Chandra Prasad Adhikary, C/1431 Dilip Barman left for Lower Bhanu Nagar under PS-Bhaktinagar, Dist-Jalpaiguri to verify the veracity of the information. On reaching there and as identified by source cordoned his house where he kept illegal illicit liquor. On arriving there found the above noted person who disclosed his identity as noted above and on search found huge numbers of liquor at his house in conceals position. On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 06 months for wrongful gain.

Accordingly I seized the same in presence of witness as per proper seizure list duly signed by the witnesses. The seizure was made in between 22.30 hrs to 22.50 hrs. On being asked he stated that he kept the same with a view to sale without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said liquor without valid license

Therefore I pray before your honour that a specific case may kindly be started against the accused namely Bijoy Mahato (22 yrs) S/o Lt. Jagdish Mahato of Lower Bhanu Nagar, Near Silicon Plaza, PS- Bhaktinagar, Dist. Jalpaiguri as per proper section of law.
