Sir,

In producing herewith following articles under proper seizure list-

1] 26 (Twenty Six) bottles of Himalayan Gold 60 up country spirit. (each bottle containing 600 ml)

I, PSI Koushik Raha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely Kabita Chhetri of Paswan Busty,Prakash Nagar, P.S-Bhaktinagar, Dist- Jalpaiguri to the effect that today on 25.06.23 at 14.30 hrs while performing evening patrolling duty, received a source information that one lady namely Kabita Chhetri W/O- Lt. Krishna Chhetri is selling liquor in his house at Paswan Busty,Prakash Nagar under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force- ASI Dipak Karmakar, C/1431 Dilip Barman, C/915 Chandra Prakash Adhikari, LCVF1060 Goma Bhandari left PS vide Bhaktinagar PS GDE NO- 1205 had been to Paswan Busty,Prakash Nagar under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source I along with my force cordoned the area. I held raid thorough search in that house and the Lady flee away from the house in course of which I recovered the above noted bottles of liquors inside of his house. I also interrogated the local people and it could be learnt that the above noted bottles of liquors were procured and stored by the above noted accused person illegally and who used to sell it to the local youths since last few months for his illegal gain. Accordingly, I seized the above noted bottles of liquors as alamats under proper seizure list .The search and seizure was made in between 15.05 hrs. to 15.55 hrs.

I, therefore pray before your good self that a specific case may kindly be initiated against Kabita Chhetri, W/O- Lt. Krishna Chhetri of Paswan Busty,Prakash Nagar, P.S-Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
