from the sale transaction from the co sharers.

Sir,

I, Sri Mritunjoy Dutta son of Late Sushil Kumar Dutta, resident of Sarojinipally, P.O. Nabapally, Prakriti Apartment, Barasat, Kolkatta -126 would like to inform you as follows:

I had submitted an written complaint with your office about a year back. I am once again submitting a reminder of the same of the following facts.

I happen to be one of the co sharers of a piece of land measuring 4 Katta 12 Chattaks ^{at Hakim Para} along with Debashish Sarkar, Dhrubajyoti Sarkar, Kakoli Sarkar and Bidyut Ghosh. The said land was sold to Asit Kumar Dey, Anima Pattra, Ananta Pattra and Nisha Rani Dey by a registered deed of sale registered on 26/03/2013.

I was supposed to receive $\frac{1}{4}$ of the total consideration amount. I was assured by the purchasers time and again to disburse to my share of money to which they have refused and neglected to pay.


I repeatedly approached Debashish Sarkar, Kakoli Sarkar and Bidyut Ghosh and was repeatedly informed that the purchasers have not payed the entire consideration amount to them. It is mentioned here that in the meantime Dhrubajyoti Sarkar had expired.

Finally finding no other alternative I wrote a letter to the above mentioned persons on 23/05/2022 asking them to give and disburse my share of the said sale consideration. He notices have received the said letters but are keeping silent as such finding no other alternative I am compelled to lodged this written complaint and request your good self to initiate appropriate action against Asit Kumar Dey, Anima Pattra, Ananta Pattra and Nisha Rani Dey so that I be not cheated from the my legitimate share of money.
