Sir,

I, Smt. Sonali Kumari daughter of Sri Santosh Kumar Jha, permanent resident of Ramsebak Jha, Tumba Jote, Matigara, Darjeeling, West Bengal, Pin- 734010, presently residing C/o Ramsebak Jha, Near Panchnai Nadi Central Bank, Dagarpur, Post Office- Pradhan Nagar, Police Station- Pradhan Nagar, District Darjeeling, Pin- 734001 would like to draw your kind attention to the fact that I was married to Sri Manish Kumar Jha permanent resident of Village Chakwa, Police Station- Hayaghat, District- Darbhanga, Pin- 847301 And presently residing at 190-191, Block (5) A, Street No. 7, Karole Bagh Central Delhi, Delhi- 110005 on 10.12.2020 at Village- Sohans, District- Madhubani as per hindu Rites and Customs

At the time of fixing of marriage there was no demand of dowry and they stated that "HUME TO LARKI DO JORE KAPRE ME DE DJEA". But as the date of the marriage was nearing my Mother-in-Law namely Indumati and my Sister-in-Law namely Sikha Jha starting demanding household items stating that "aapki beti ko hi kaam ayega ye saaman" and my father was left with no option but to fulfill their demand of Furniture, Bed, Almira, Trunk, Sofa, along with gold articles by selling land.

After the marriage when I went to my in laws house at Village Chakwa, I was astonished by the behavior of my Mother-in-Law and Sister-in-Law. They immediately told me to hand over all my gold jewelry and further they opened my bag and start searching my bag, took out my keypad mobile phone which I was given by my brother (without sim stating to buy sim there locally) and hit it in ground breaking it and started using slang against me and family members for not bringing cash and enough gold as dowry. From the very first day I was subject to physically and mentally torcher and was treated as slave. Later on my Brother-in-Law namely Anish Jha, Ajit Jha (husband of Sikha Jha) and my own aunt son (Bhua son) namely Bikash Ch. Jha son of Sunil Jha resident of Madhubani joined them in torcher, they started using slang and touching me indecently and I was left with no option but to bear torcher. The said Bikash Ch. Jha who is my brother knowing my condition started giving me indecent proposal in order to save me from my in laws.

Later within 1 (one) month I was taken to Delhi by my in Laws and within few days my Husband mortgaged all my gold jewelry at Muthoot Finance. I was not allowed to speak to my parents and they allowed me to speak to my parents only in speaker mode and kept the mobile in their hand and told to cut the phone stating that I have household works. They once forced me to drink Phenyl by my husband, brother-in-law, mother-in-law and my sister-in-law and was constantly vomiting for two days but no medical treatment was provided to me. They started hitting me in small issue. They always stated that they will sell me and lodge fir against me stating that I have eloped with someone. My husband started talking to his friends disguising as me over message/social media and started keeping screenshot of the chats stating that they will sell me and show that I have eloped with his friends. But the irony is that I

In the month of December, 2021 when my uncle namely Ashutosh Jha came to meet me while he was returning from Vaishnudevi, I informed him all the matter and he requested my in laws to send me to my parents home for few days and they refused and my uncle left and informed the whole matter to my brother and in the month of January, 2022 my brother namely Bhagwanjee Jha came to Delhi and before leaving my sister-in-law and my mother-in-law took my gold ring and mangalsutra from me and stated not to return back and then my brother took me to my paternal home at Sohans, Madhubani where my father did not supported me and stated to leave home. Later I was total in mental trauma and took shelter in my uncle house at Dagapur, Siliguri with a condition that I will not indulge in any Police and Court case as he is a brahmin pundit by profession doing puja and will not support in any cases. Being left with no option and in need of shelter I agreed to his terms and condition.

After that they tarnished my image in my Village and relatives eyes but left with no option I kept mum as there was no one to support me.

Later on 20.02.2023 my mother-in-law send a whatsapp message to my father stating "10 DIN ME TALAK KA KAAM PURA KRO TAIM DIYA" and following which my uncle namely Ashutosh Jha approached my in laws and arranged a meeting for separation on mutual consent in the month of March, 2023 between my uncle and my in laws and my uncle along with my some relatives went to Chakwa but my in laws did not turn up and started threatening them over phone stating "Larki ko hum kahi ka nahi chorega".

In the second week of June, I received a notice from Family Court, Madhubani where my husband filed a case under section 9 of Hindu Marriage Act and to the surprise my just six to eight days back my husband send a chat video which he had made to my brother and uncle mobile with an intention to defame and blackmail me.

Madam, after bearing physical and mental torcher for one year and being in trauma for two year I have decided to fight for myself alone without any support and request you to kindly investigate the matter and take necessary action against the said Manish Kumar Jha (7838228440), Indumati (9310098923), Sikha Jha (8294704510), Ajit Jha (7654621607), Anish Jha (7838523666) and Bikash Ch. Jha (9771248649) as per law.
