Sub: Complaint against my mother-in-law namely Smt. Gauri Paul, Wife of Late Prakash Chandra Paul, brother-in-law, Shirshendu Paul, Son of Late Prakash Chandra Paul, uncle-in-law, Shankar Dutta and Ranjit Dutta, both son of Late Dinesh Chandra Dutta, aunt-in-law, Gayatri Bhawal, Wife of Jiban Bhawal.

Respected Sir,

I, **Smt. Dipika Pal**, Wife of Subhendu Paul, resident of Tumulpara, Ward No.4 of S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling, do hereby lodge a complaint against my mother-in-law namely Smt. Gauri Paul, Wife of Late Prakash Chandra Paul, brother-in-law, Shirshendu Paul, Son of Late Prakash Chandra Paul, uncle-in-law, Shankar Dutta and Ranjit Dutta, both son of Late Dinesh Chandra Dutta, aunt-in-law, Gayatri Bhawal, Wife of Jiban Bhawal, resident of Deshbandhu Para, near Mahamaya Kalbari, P.O. & P.S. Siliguri, Dist. Darjeeling to the effects as follows:-

- (1) That my marriage was solemnized on 24-02-2012 along with said Subhendu Paul as per Hindu rites, rituals and customs.
- (2) That after the aforesaid marriage, my husband and my in-laws brought me to my matrimonial home at Tumulpara, Ward No.4 of S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling and since then my mother-in-law with the incitement, instigation and abetment of my other in-laws has been committing mental torture upon me at regular interval by abusing me in abusive and filthy languages and also at regular interval verbally abuse me of not bringing enough dowry in cash and kind from my parental home.
- (3) That on 22-11-2015, at about 7:00 pm my mother-in-law on the instigation and abetment of my other in-laws abuse me in most indecent languages and physically assaulted me by slapping and grabbing my hair and tried to drove out of my matrimonial home but due to the intervention of para people, my in-laws were restrained to throw out of me from my matrimonial home.
- (4) That on regular interval, my mother-in-law with the instigation, incitement and abetment of my other in-laws physically abuses me by slapping and throwing shoes and other articles at me with a ill view and wild motive to drive me out of my matrimonial home.
- (5) That my mother-in-law and my brother-in-law with the instigation, incitement and abetment of my other in-laws continuously commits mental torture by creating pressure upon me to leave my matrimonial home else threatens me of dire consequences.
- (6) That my mother- in-law with the abetment of my other in-laws regularly abuse me in obscene and abusive languages and ridicules and scolds me of not bringing enough dowry in cash and kind from my parental home to their satisfaction and threatens me of driving me out of my matrimonial home.

- (7) That it is pertinent to mention here that my father-in-law (since deceased) was/is the owner of the land measuring 1.5 Katha together with two storied building standing on the said land, recorded in Khatian No. 161, in Plot No. 2055, J.L. No. 110, Mouza- Siliguri Madhya Paschim, P.S. Siliguri, District- Darjeeling and since after the demise of my father-in-law in the 2012, my mother-in-law and my brother-in-law with the instigation and abetment of my other in-laws are/were in a wild mission to sell out the said property and to fulfill their evil motive, they are regularly and continuously committing mental torture upon me by hurling abuses in filthy languages so that I may be compelled to leave my matrimonial home and they can sell the property.
- (8) That on 10-06-2023 at about 2:00 pm to 2:30 pm, my mother-in-law with the instigation and abetment of my other in-laws hurled abuses in filthy languages and threatened to drive me out my matrimonial home else she will cause physical violence upon me.
- (9) That my mother-in-law with the instigation and abetment of my other-in-law had been continuously committing mental torture upon me by hurling abuses most indecent and immodest languages with naming my parents and threatens me to drive me out my matrimonial home uttering and declaring openly that I have no right to live in my matrimonial home.

So, therefore, I humbly request you take stringent legal action against my in-laws abovenamed at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
