Respected sir,

In producing herewith arrested accused person namely TINKU ROUTH (Male/35 yrs), S/O- LT. Babulal Routh of Mahananda Colony, Ward no. 01, PO+PS. Pradhannagar, Dist. Darjeeling under arrest along with the following seized articles i.e.

- i) 30 (Thirty) Bottles of 70 UP "Himalayan FATA FATI" Country Spirit each bottle containing 300 ml,

I, SI Mrinal Basunia presently posted at Bhaktinagar P.S, Dist Darjeeling lodge this written complaint to the effect that on 26.06.2023 myself and forces were detailed for mobile van duty vide Bhaktinagar PS GD entry No. 1249, dated 26.06.2023. During mobile van duty at 13.15 hrs on reaching at sevoke road myself have detain one person namely Tinku Routh, near P.C. Mittal Bus Terminus who was carrying some illicit liquor to sell from his shop. On searching, we found total 30 (Thirty) bottles of "Himalayan FATA FATI" 70 UP country spirit each bottle containing 300 ml. On interrogation the said person stated that he is running this business and sell illicit liquor without any licence or valid document. On demand he disclosed his identity as TINKU ROUTH (Male/35 yrs), S/O- LT. Babulal Routh of Mahananda Colony, Ward no. 01, PO+PS. Pradhannagar, Dist. Darjeeling. On further interrogation he stated that he is involved in illegal selling of the above mentioned country spirit from his house/shop to make good profit. On physical verification the above noted alleged person failed to produce any valid documents in respect of selling the said illicit liquor articles.

Subsequently, in presence of witnesses I prepared a seizure list of the above noted articles under proper seizure. The whole processes of seizure has made in between 13.25 hrs to 13.45 hrs and arrested above noted accused person after preparing arrest memo stating the ground of arrest.

Therefore, I request before you that a specific case against the accused person namely TINKU ROUTH (Male/35 yrs), S/O- LT. Babulal Routh of Mahananda Colony, Ward no. 01, PO+PS. Pradhannagar, Dist. Darjeeling may kindly be start and arrange for its investigation.
