Respected Sir,

I, Jharna Chandra Mondal, W/o Chandu Mondal, residence of Ashighar, near Laxmi Dharmakata, P.O- Ghoghomali, P.S- Bhatinagar, District Jalpaiguri do hereby want to state as follows that on 25/06/2023 at around 11 p.m me along with my friends namely 1. Bipin Prasad S/o Ganesh Prasad, 2. Mitu Hazra D/o Naro Hari Hazra, 3.Mallika Mistri D/o Mohan Mistri 4. Lokkhi Mahato D/o Haribansh Mahato entered in Nasha Disco & Pub. We all were enjoying our party and while dancing around (12.30 a.m) I got pain on my feet for that, I took a rest and sit down on a sofa and I took off my shoe after that two bouncers came near by me and asked me to wear the shoe it is not allowed to open shoe inside the Disco, Than I wear my shoe back, again they came near by me and forced me to dance with some unkown persons present there, I directly disagree with the bouncers and I stated I have came here with my friends so I will dance with them. While dancing that unkown persons started touching in my body with bad intention. I stated them stay away from me than the male bouncer of the said pub came around me and started using fealthy language and suddenly slap me and start beating me with fist and blows, after seeing the incident my friends ran away and contact with Mr. Dilip Sarkar (one of my good friend), after beating me inside the Disco they dragged me out of the Disco and again they started beating me with steel pipe and I got gravious injury, they also turned my clothes and touches in my private parts and they also snatched my 1 (one) Gold Chain with Gold Locket of Lord Shiva, 2(two) Gold earring, , Cash Rs 50,000 ( fifty thousand) after some time Dilip Sarkar came to rescue me but again they started beating to Dilip Sarkar, the bouncers of Nasha Disco & Pub they break my iphone 13 pro and also stole Dilip Sarkar oppo mobile phone. They were eight to ten bouncers in number. I did not know the name of bouncers but I can identify them and there was many camera installed outside and inside the Pub and we were taken to the Siliguri District Hospital for treatment. Medical papers along with other documents attached with written complain.

In such circumstances, finding no other alternative I come before you with this present complaint and request you to take necessary action in respect of the above matter as per law and to help me to get justice.
