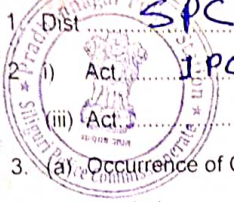

Subject: - **First Information Report**

Respected Sir,

I, the undersigned would like to draw your kind attention towards an incident that took place day before yesterday i.e., on 23.06.2023 in the morning when I was cooking at my house, my younger son i.e., Deepak Mahato who is doctor by profession came to the kitchen while I was cooking and sexually harassed me by touching my private body parts and also abused me verbally, somehow I escaped from the kitchen and went downstairs where my daughter i.e., Jyoti Mahato was cleaning the dishes I asked a utensil to her as I was cooking, now she also started to torture me, further my son and my nephew named Satrohan Mahato, son of Rajkumar Mahato, permanent resident of Tajpur, District-Samastipur, Bihar, currently residing at my place came downstairs and joined their sister i.e., my daughter Jyoti Mahato and all three of them started hitting me with fist and blows, they also snatched my mobile phone and tied my hands and pressed my nerves by saying "mein doctor hoon aur mujhe acche se pata hain ki konsa nerve dabane se aadmi marjata hain" in order to kill me. It is pertinent to mention here that at that time husband namely Rajendra Mahato also came in a drunken state and started insisting them to torture me more. I

was not able to contact anybody neither police at that time for help. They tortured me for straight five hours and then pushed me from the stairs dragging me out of my own house by holding my hairs. I was not able to defend myself and was helpless. On the way I met one stranger and asked him for his cell phone and then I made a call to the police. The three of them somehow came to know that I informed the matter to the police so when I came back to home with the police they had ran out of the house. They also removed door lock and kept the keys with them so that I won't be able to protect myself from them. I have suffered injuries in both of my hands and was there after treated at Siliguri District Hospital. Copy of the said prescription is also annexed herewith this complaint.

It is pertinent to mention that I have file a case on Protection of Women under Domestic Violence Act, 2005 after hearing, the Ld. Court was pleased to pass a protection and residence order on my favor, where the Accused Persons are restrained from disturbing my peaceful possession but the said accused persons are against the order granted by the Ld. Court where they are disturbing my peaceful possession as well as torturing me over my own property. The copy of the order is annexed herewith this complaint.

I could not come earlier before the police due to my health issues as because I was injured. In view of the above facts and circumstances, I do most humbly pray before your good office to take stern legal action against these accused persons for

commission of heinous offences as unveiled hereinabove and kindly book them according to the provisions of law and oblige.
