Sir,

In producing herewith one accused person namely Sameshwar Roy (35), S/O- Late Tathaya Nath Roy of Sukanta Nagar Auto Stand W/no.38, SMC, PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

- (1) 14 (Fourteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.155/- (Total- 8.4 Liter & Amount Rs. 2170/-).

I SI Pradip Kr Singh of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely Sameshwar Roy (35), S/O- Late Tathaya Nath Roy of Sukanta Nagar Auto Stand W/no.38, SMC, PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 26.06.2023 evening as per order of O/C Ashighar OP I along with SI Swapan Kr Ghosh ASI/ 877 Munna Ahmed and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti-social elements, warrantees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no.627 Dt 26.06.2023 in course of which I received information from my source that one Sameshwar Roy kept huge numbers of bottles of liquor inside a bag and selling the said bottles of liquor by turning gouge to the local youth of Purba Chayanpara Near Nag Nurshing Home in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Purba Chayanpara Near Nag Nurshing Home area to verify the veracity of information. On the way I called two local person namely (1) Sujit Roy (31) S/O Late Satish Roy of Ashighar Coloney PO Ghogomali PS Bhaktinagar Dist. Jalpaiguri and (2) Ajay Sarkar (31) S/O Swapan Sarkar of Badurbagan PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Purba Chayanpara Near Nag Nurshing Home area as indicated by my source I along with my accompanied party surrounded the said Sameshwar Roy at Purba Chayanpara Near Nag Nurshing Home. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched the above noted accused person, in course of which I recovered the above noted bottles of liquor which were kept inside a bag carrying by him. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 14.45 hrs and 15.15 hrs on 26.06.2023.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person Sameshwar Roy (35), S/O- Late Tathaya Nath Roy of Sukanta Nagar Auto Stand W/no.38, SMC, PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
