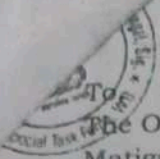

In producing herewith two (02) arrested accused persons namely (i) Md. Alamgir Ansari (33 Years) S/O Lt. Abid Ansari of Hargovindapur, Vill & PO Kahala, P.S Ratua, Dist. Malda and presently staying at Village Tarijote, New Rangia, Shiv Mandir, PS Matigara, SPC and (ii) Fekan Momin (35 Years) S/O Ishfak Momin of Shyampur Chawki, PO Mirdatpur, PS Manikchawk, Dist. Malda along with seized articles as per seizure list viz.

i. One transparent plastic pouch sealed with cellotape containing Brown coloured Powder, believed to be Brown-sugar weighing approximately 104 gms. seized from the exclusive possession of Md. Alamgir Ansari (33 Years) S/O Lt. Abid Ansari of Hargovindapur, Vill & PO Kahala, PS Ratua, Dist. Malda kept concealed inside the right pocket of his pant and Marked as **Exhibit-A.**

ii. One transparent plastic pouch sealed with cellotape containing Brown coloured Powder, believed to be Brown-sugar weighing approximately 105 gms. seized from the exclusive possession of Fekan Momin (35 Years) S/O Ishfak Momin of Shampur Chawki, PO Mirdatpur, PS Manikchawk, Dist. Malda kept concealed inside the right pocket of his pant and Marked as **Exhibit-B.**

iii. One blue coloured Vivo Android smart mobile phone having IMEI No-860960050406895 and IMEI- 2- No- 860960050406887 having connection Sim No. 9475092547 & 7797916128. seized from the possession of Fekan Momin.

iv. One blue coloured Redmi Android smart mobile phone having IMEI No-1-861620050844854 and IMEI- 2- No- 861620050844862 having connection Sim No. 9144790513 seized from the possession of Fekan Momin.

v. One Original PAN Card in the name of Md. Alamgir Ansari S/O Isfak Momin bearing PAN No. CSXPM7939K.

vi. Indian Currency Notes Cash Rs. 850/- seized from Md. Alamgir Ansari.

vii. One blue coloured Super Splendour Motor Cycle bearing Reg. No. WB-74B/F1534 with key and without documents in which both the accused persons were travelling.

I, SI Norbu Wangdi Dukpa of STF, WB do here by lodge this written complaint to the effect that on 26.06.2023 at about 10.30 hrs, I received a specific information provided by a credible source that today, 02 persons were coming towards Siliguri from Malda in a Motorcycle bearing Registration No WB 74BF 1534 carrying huge quantity of Contraband drug Brown Sugar /Heroin for its disposal and would reach Shivmandir Area shortly.

The same was duly reduced in writing vide Special Task Force West Bengal, HQ at Siliguri GDE No. 105 dated- 26.06.2023 and the same was intimated to Shri. Sudip Bhattacharjee, Dy.S.P, Special Task Force, West Bengal, HQ at Siliguri who brought the information to the superior authority of STF headquarters. He then order me to make a raid team.

In order to verify the veracity of the information received and at about 11.35 hrs after obtaining necessary order I along with raid team consisting of myself, SI Paribesh Chettri, ASI Shuvokar Kundu, C/118 Jayanto Sarkar and C/115 Ajimul Hoque all of STF, WB left STF WB, HQ at Siliguri Office for Shivmandir Area along with drug testing kit, Laptop, Video Camera, Printer, Digital weighing machine, Rubber Seal, Brass Seal and Gala, UPS, envelope and other articles used during NDPS Raid availing Govt. Hired vehicle bearing Reg. No. WB 74W 5163.

At about 12.10 hrs, we arrived Near North Bengal University Gate No 1, Opp. WBHSE Office, Shivmandir Area under Matigara PS, Siliguri Police Commisionerate and met with my source. I then looked for public witness who would bear witness to the entire process. On anticipation of productive raid, I asked several passerbies to be witness to the search, seizure and arrest process but no one agreed to be witness as they were going someplace else. Out team prepared for ambush and waited there.

Then at about 12.18 hrs, my source identified the targets who were riding on a Blue coloured Motorcycle vide Registration No. WB 74BF 1534 which was coming from Bagdogra side towards Siliguri. I along with our team was able to apprehend two persons riding the motorcycle and stop them. Then, I along with my team cordoned them and I introduced myself as a Police officer and started to question them. On being asked, they disclosed their name and address as noted above. They initially made contradictory statements at different times of examination. Finally on continuous examination they stated that they are carrying and possessing Brown Sugar (Contraband Drugs) with them and that they did not possess any valid document for carrying the same. They further confessed that they were smuggling the contraband drug for earning easy money. On learning that

they both possessed Brown Sugar (Contraband Drugs) as per the procedure under NDPS Act. I then sent requisition to BDO Matigara through a Messenger C/115 Ajimul Haque of STF, WB, HQ at Siliguri but the messenger returned and informed that he was not able to find the BDO officer at office and was present there so he returned to the spot.

I brought this development to the notice of Inspector Shri. Biswasroy Sarkar, Special Task Force, West Bengal, who instructed me to detain those persons on the spot and he would arrive soon.

Meanwhile at about 13.40 hrs, Inspector Shri Biswasroy Sarkar arrived on the spot. I introduced him as Inspector of Police who is a Gazetted officer to both the detained persons. I then narrated the development to Inspector Shri Biswasroy Sarkar in a nutshell.

After that the provisions of section 50 of the NDPS Act, 1985 (as amended) was explained by me to the above noted 02 detained persons and the same was given to them in writing stating that they have legal right to tender their personal search in front of a magistrate or a gazette officer duly empowered under section 42 of the NDPS Act, 1985 (as amended) and further intimated them that if they wish they may search every member of the searching team before their personal search could be commenced. In writing they declined to search the team. I also served Notice to them whether they are willing to conduct their persons search in presence of Gazetted officer Inspector Shri Biswasroy Sarkar, STF, WB. In reply they made written consent to be searched in presence of Gazetted officer Inspector Shri Biswasroy Sarkar, STF, WB.

After that, search cum seizure was started at 13.50 hrs, in front of police and independent witness and under direct supervision of Inspector Shri Biswasroy Sarkar, I started search procedure which was thoroughly videographed by SI Paribesh Chettri of STF, WB.

At first, I searched (i) Md. Alamgir Ansari (33 Years) S/O Lt. Abid Ansari of Hargovindapur, Vill & PO Kahala, P.S Ratua, Dist. Malda and presently staying at Village Tarijote, New Rangia, Shiv Mandir, PS Matigara, SPC and was able to seize one Blue Color vivo Android Smart Mobile phone having IMEI No. 860960050406895 & IMEI 2 860960050406887 along with Vodafone Idea SIM Card having connection no. 9144790513 from his possession, recovered one Transparent plastic pouch sealed with cello tape containing brown powder believed to be Brown Sugar weighing Approx 104 gms which was concealed in his right pocket of his pant, I cut open the plastic and drew a small sample and tested with field drug testing kit which came positive for Morphine, Codine, Heroine, I then sealed and packed the same and marked label as Exhibit 'A' and seized the same I also seized one PAN Card in the name of Alimgir Ansari bearing PAN No. CSXPM7939K.

I then searched (ii) Fekan Momin (35 Years) S/O Ishfak Momin of Shampur Chavki, PO Mirdatpur, PS Manikchawk, Dist. Malda and was able to recover and seize one blue colored Redmi Android Mobile Phone having IMEI 861620050844854 & IMEI 2: 861620050844862 along with 9144790513 and recovered one Transparent plastic pouch sealed with cello tape containing brown powder believed to be Brown Sugar weighing Approx 105 gms which was concealed in his right pocket of his pant which I cut open the plastic and drew a small sample and tested with field drug testing kit which came positive for Morphine, Codine, Heroine, I sealed and packed the same and marked label as Exhibit 'B' and seized the same.

I then took the Motorcycle Keys from the Blue colored Motorcycle bearing Reg. No. WB74BF 1534 but found no documents regarding the ownership of the vehicle. Accordingly, I seized the same and all the articles under proper seizure list and witnesses.

I further examined the above noted 02 detainees and they confessed their guilt and revealed that they are habitual dealers of Narcotics substance like Brown Sugar since long time. As they used to collect the same from Murshidabad and Malda and disposed off the same in clandestine manner at different areas like Siliguri and adjacent areas under West Bengal. They stated that they are willing to cooperate and help Police in recovery of more contraband articles and arrest of their associates. After their examination, I recorded their statements u/s 67 of NDPS Act.

Thus, a reasonable belief having been formed that an offence has been committed in contravention of the section 21(b)/25/29 of the NDPS Act, 1985 (as amended) and that recovered articles were liable to be confiscated U/S-60 & 61 of the NDPS Act, 1985, the entire contraband of Brown Sugar were seized U/S- 43 of the NDPS Act, 1985 (as amended) under proper seizure list duly prepared by me. I took dated signature of the police witnesses, all two (02) accused persons, signature of Inspector Shri Biswasroy Sarkar, as Gazetted officer and put my signature as seizing officer. Copy of seizure list given to the detained persons. I then prepared inventory lists.

Thereafter, all the seized articles were properly labeled. Took signatures of witness, and both (02) accused persons of contraband articles in the labels and marked accordingly. The entire process of recovery and seizure was supervised by Dy.SP Shri Sudip Bhattacharaya, STF WB.

Thereafter, I arrested the above noted three accused persons after communicating their ground of arrest and issued arrest memo to them accordingly. The entire Search, seizure, Label, Seal & packing and inventory were done in between 13.50 hrs and 15.50 hrs.

The process of search & seizure was videographed, complying to the order from the Honorable High Court, Calcutta and the memory card bearing the videography was also duly seized

Malda and presently staying at Village Tarijote, New Rangia, Shiv Mandir, PS Matigara, Siliguri Police Commissionerate and (ii) Fekan Momin (35 Years) S/O Ishfak Momin of Shampur Chavki, PO Mirdatpur, PS Manikchawk, Dist. Malda and others involved in this racket.
