

photos and videos in my smartphone and want don't
money with me. then monas uadhaya want more
money from me by blackmailing. I don't share
more money amount to him then he share our
personal relationship photos and videos on public
platform and social media. That time I was
totally mentally hamper and temper also harassment
by him after that incident I shared more money
to him from dated 08-02-2022 to 07-06-2023 by
online transaction for don't share any photos and
videos of our personal relationship on any public
platform and social media, then I stop sending
money to him and I want any cheated money
