In producing here with the seized articles viz:-

- (i) 05 (five) no's Indane domestic Gas Cylinder each partially loaded
- (ii) One Gas pipe length about 5ft fitted with Gas regulator.

Under proper seizure list. I SI Goutam Kundu of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge a written complaint against the owner namely Dilip kr. Ghosh owner of "Joy Guru Fulbari Mistanna Bhardar" located at Fulbarimore PS New Jalpaiguri Dist- Jalpaiguri who was illegally procured the domestic Gas cylinder at his Sweet shop cum sweet preparing factory styled as "Joy Guru Fulbari Mistanna Bhardar" for commercial purpose without any valid documents or licence to the effect that today i.e. 24.06.23 at about 12:45 hrs received an information from reliable source that above noted sweet shop styled as "Joy Guru Fulbari Mistanna Bhardar" situated at above mentioned address using the domestic Gas cylinder at his sweet preparing factory for using commercial purpose for his wrongful gain.

Accordingly, the matter informed to ACP EB SPC and as per his direction I, along with, ASI Arghya Das, C/924 Avijit Kar, CV -873 Kunal Biswakarma all of EB SPC with investigation kit left for New Jalpaiguri PS area vide EB SPC C.C No 81/23 Dt. 24.06.2023. The matter informed to New Jalpaiguri PS for providing local police assistance vide New Jalpaiguri PS GDE No. 1206 Dtd. 24/06/23 and accompanied with local van officer and forces namely ASI Pranab Majumder, C/949 Bappi Mondal, NVF/0070 Nipon Roy vide MCC NO 1349/23 Dated 24/06/2023 had been to Fulbari more, under New Jalpaiguri PS to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure. As per source information we reached and entered into the Sweet shop cum sweet preparing factory styled as "Joy Guru Fulbari Mistanna Bhardar" situated at Fulbarimore under New Jalpaiguri PS. During search found worker of Sweet shop making sweet items by using the domestic Indane Gas cylinder without any valid documents for commercial purpose, On demand they failed to produce any valid documents in support of using the Indane domestic gas cylinders in the kitchen of said sweet shop for commercial purpose. Further local enquiry it revealed that the above noted sweet shop owner noted above is using the domestic gas cylinder for preparing food items at the Sweet shop for commercial purpose in order to wrongful gain without any valid document. I also invited three independent witnesses namely (1) Dipu Singh (45yrs) S/O Lt. Rajen Singh of Paglahat, vill- Kowalegach, PS-Rajganj, Dist-Jalpaiguri (2) Ramesh Roy (62 yrs) S/O Lt. Sani Roy of Dalijote, PS Rajganj, Dist-Jalpaiguri (3) C/924 Avijit Kar of EB SPC.

During further local enquiry it could be learnt that the owner of sweet shop namely Dilip kr. Ghosh owner of "Joy Guru Fulbari Mistanna Bhardar" located at Fulbarimore, Dist- Jalpaiguri using the domestic gas cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles from the Sweet shop cum sweet preparing factory styled as "Joy Guru Fulbari Mistanna Bhardar", staff in presence of the staff of sweet shop. On being asked they unable to produce any supporting documents for using domestic gas cylinder at the Sweet shop cum sweet preparing factory for commercial purpose. I seized the articles noted above from the Sweet shop cum sweet preparing factory after preparing proper seizure list and label in the presence of witnesses noted above. The seizure was made in between 13.45 hrs to 14.15 hrs. But found the owner of Sweet shop Dilip kr. Ghosh absconded from the shop to evade police arrest to seeing the police party.

Hence, I pray that a specific case may kindly be started under section 285 IPC r/w sec.7(i)(a)(b)(c) of Essential Commodities Act- 1955 against the accused person namely Dilip kr. Ghosh owner of Sweet shop cum sweet preparing factory styled as "Joy Guru Fulbari Mistanna Bhardar" situated at Fulbarimore under New Jalpaiguri PS Dist- Jalpaiguri and arrange for its investigation.
