Respected Sir,

I, Smt. Sukanya Choudhury, Wife of Sri Joy Kumar Deb, Daughter of Sri Karuna Choudhury, resident of Bari Apartment (Ground Floor), Sukanta Pally, Ward No.33 of S.M.C., Near Shiv Shakti Kailbari, Post Office - Siliguri Bazar, Police Station - New Jalpaiguri, District - Jalpaiguri, PIN - 734005, would like to bring the following facts to your kind notice:-

1. That on 18/02/2022 I was married to Joy Kumar Deb, Son of Nirmal Chandra Deb, resident of Bhaktinagar, Near Aurobindo Society, Deshapuriya Sarani, Ward No. 34 of S.M.C., Post Office - Bhaktinagar, Police Station - Siliguri and the said marriage was solemnized at R.S. Bhawan, Tinbatti More, P.S. - New Jalpaiguri as per the Hindu Rites & Customs in presence of the relatives and friends of both the sides.
2. That after that I went to my matrimonial house in the above noted address.
3. That after few months of my marriage my mother - in - law namely Ali Rani Deb and my sister - in - law namely Aparna Deb Singh started torturing me mentally as I am a trained beautician and I used to work after marriage. That whenever I returned from work my mother - in - law and my sister - in - law, who is married but most of the time she used to stay at matrimonial house used abuse me with slang languages and also put question on my character.

It is pertinent to mention here that my husband is an alcoholic person and habitual drinker and he used to force me to consume alcohol and whenever I refused he used torture me both physically and mentally.
4. That such torture increased day by day and after few days my father - in - law namely Nirmal Chandra Deb and my husband also joined them and used to abuse me with slang languages regularly and also told me a characterless lady and husband of my sister - in - law namely Akash Singh and his father (Name not known) both are resident of Beside Biswadeep Cinema Hall, Post Office & Police Station - Pradhan Nagar, District - Darjeeling, PIN - 734003 used to instigate my husband and my in - laws sometimes over phone and sometimes being present.
5. That day by day the rate of their torture increased up to such an extent that I was compelled leave my work.
6. That after that whenever I went visit my parents my husband and in - laws used to abuse me with slangs and told me that I have stop contact with my parents otherwise my husband will give divorce and they will give another marriage of my husband.
