Sir,

With due respect, I am producing herewith 01 (one) arrested accused person namely Monoj Singh(45yrs)S/O Lt Sunil Singh of South Colony Bazar, P.S- NJP, Dist- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 10 (Ten) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml)
2. 15(fifteen) bottles of Himalayan FATA FATI 70 UP Spirit(each bottle containing 300ml)

I, ASI Dhruba Misra presently attached with NJP PS under your kind control beg to state that on 24/06/23.06 at 19:05 hrs I received a secret source information that one person namely Monoj Singh(45yrs)S/O Lt Sunil Singh of South Colony Bazar, P.S- NJP, Dist- Jalpaiguri is selling ID liquor illegally at abandoned New South Colony Bazar under New Jalpaiguri PS, Dist- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No- 1221 date: 24.06.2023 and informed the fact to you. As per your kind direction and instruction myself along with C/1044 Hari Kherwar, C/453 Uttam Dey all of NJP PS, SPC left for New Jalpaiguri Hospital Road, under New Jalpaiguri PS, Dist- Jalpaiguri to work out the information in hand. At 19:40 hrs we arrived at the shop of Monoj Singh(45yrs)S/O Lt Sunil Singh of South Colony Bazar, P.S- NJP, Dist- Jalpaiguri and being identified by the source I held raid at the Southcolony Bazar where the above noted accused person selling ID Liquor. Accordingly as per the indication of Source I managed to apprehended him. During raid the persons who were taking liquor was able to fled away from the spot. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19:45 hrs to 20:25 hrs on 24.06.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Monoj Singh(45yrs)S/O Lt Sunil Singh of South Colony Bazar, P.S- NJP, Dist- Jalpaiguri and arrange for its investigation.
