Sir,

In producing herewith 16 (Sixteen) sealed bottles of liquors label as Himalayan Gold 60 up country sprit each bottles containing 600 ml. and 12 (twelve) pieces of plastic glass kept in a plastic bag seized under proper seizure list from the house of one namely Chitramohan Barman @ Debaru Barman (age approx 51 yrs), S/O Tiren Barman of Farabari near Bandhan Bank, P.O Sahudangi Hat, PS- NJP, Dist: Jalpaiguri. I SI Swadesh Saha of Ambari Falakata OP under NJP P.S lodge this written complaint to the effect that on 25.06.2023 at 14:15 hrs in course of raid duty, received a source information regarding the selling liquor at Farabari under Ambari Falakata OP and informed the matter to O/C Ambari Falakata OP and O/C NJP PS. As per direction of O/C Ambari Falakata OP and O/C NJP PS myself along with accompanying force rushed to Farabari at the house of Chitramohan Barman @ Debaru Barman (age approx 51 yrs), S/O Tiren Barman of Farabari near Bandhan Bank, P.O Sahudangi Hat, PS NJP, Dist: Jalpaiguri vide Ambari Falakata OP GDE No-940, Dt: 25.06.2023. At 14:35 hrs reached at and as identified by the source and local people of Farabari area conducted raid at the house owned by Chitramohan Barman @ Debaru Barman (age approx 51 yrs) in presence of local witnesses. On search of the house a nylon bag containing 16 (Sixteen) sealed bottles of liquors label as Himalayan Gold 60 up country sprit each bottles containing 600 ml. was found which was kept conceal behind one wooden Table.

Prior taking any steps, I waited for the arrival of the house owner till 15.25 hrs but none appeared. Accordingly in presence of witnesses I prepared seizure list and the nylon bag containing 16 (Sixteen) bottles of liquors label as Himalayan Gold 60 up country sprit each bottles containing 600 ml. from the house owned by Chitramohan Barman @ Debaru Barman duly signed by the witnesses and left the spot. The seizure was made between 15:35 hrs to 15.55 hrs.

Under the above circumstances, I pray to your kind end for starting a specific case under proper section of law against the accused Chitramohan Barman @ Debaru Barman (age approx 51 yrs), S/O Tiren Barman of Farabari near Bandhan Bank, P.O Sahudangi Hat, PS- NJP, Dist: Jalpaiguri under proper section of law and arrange for its investigation. --
