Sir,
In producing herewith one accused person namely Namole Roy (35 yrs), S/o - Lt. Sukhindar Roy of Farabari-Velkipara, P.O-Sahudangi Hat, PS - NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 15 (fifteen) sealed Bottles of Himalayan Gold 60 up Country Sprit each bottle containing 600 ML.
2. One nylon bag.

I, ASI. Kajal Chakraborty of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 25.06.2023 at 17.05 hrs under supervision of O/C, Ambari-Falakata OP myself along with SI. P.R.Bhutia, SI. Swadesh Saha, C/625 Bhabendra Das, C/975 Swarup Basak left for conducting joint raid with Excise Department, Rajganj Circle against illicit liquor at different places under Ambari-Falakata OP's jurisdiction. This refers to Ambari Falakata Out Post GDE 944, dated 25.06.23. At 18:45 hrs we reached at Farabari-Velkipara, sometimes after being identified by the source our party held raid at the house of above noted accused person and recovered the above noted articles from the possession of accused person namely Namole Roy (35 yrs), S/o - Lt. Sukhindar Roy of Farabari-Velkipara, P.O-Sahudangi Hat, PS - NJP, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same among the local customer since long for his wrongful gain. Therefore, I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses namely 1) C/625 Bhabendra Das Of Ambari-Falakata OP and 2) C/975 Swarup basak Of Do. The seizure was made between 19.05 hrs to 19:15 hrs. Then I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Namole Roy (35 yrs), S/o - Lt. Sukhindar Roy of Farabari-Velkipara, P.O-Sahudangi Hat, PS - NJP, Dist- Jalpaiguri under proper section of law.
