With due respect, I am producing herewith 01 (One) arrested accused persons namely Sankar Adhikari (26) s/o Lt. Sunil Adhikari of Kachakali, PS- Chopra, Dist- Uttar Dinajpur under arrest. The ground of arrest duly been communicated with him and the following articles under seizure :-

- (i) 01 (One) Improvised small fire arms one shooter measuring 23 cm in length Approx including its 13 CM barrel with one trigger, striking hammer, striking pin in working condition Marked as "Exhibit-"A" and loaded
- (ii) One live ammunition marked as Exhibit-"B"

I, SI Pradeep Diyali of NJP PS, SPC do hereby lodge this written complaint against the above noted arrested accused persons. In this regard, I beg to report that today i.e. on 27.06.2023 at 1425 hrs I received a secret information that one persons came to Mahananda Barriage, under New Jalpaiguri PS, Dist- Jalpaiguri with improvised fire arms and ammunition to deliver the same to his design customer. Accordingly, I diarised the information in General diary vide NJP PS GDE No-1395 dated 27.06.2023 and informed the fact to you. As per kind order and direction myself along with ASI-Khagen Barman, C/453 Uttam Dey, C/1044 Hari Kherwar, VP/13 Jamirul Islam, all of NJP PS, SPC left for Mahananda Barriage, under PS-New Jalpaiguri PS, Dist- Jalpaiguri with investigation kit to work out the information in hand by Govt. vehicle. We reached at the spot i.e. Mahanda Barriage, at about 1545 hrs and as indicated by the source we able to apprehend one persons. On being asked he disclosed his identity as noted above. As per source information, that he possessed improvised fire arms and ammunition Hence, immediately I searched the above noted detained person and found (i) 01 (One) Improvised small fire arms one shooter measuring 23 cm in length Approx including its 13 CM barrel with one trigger, striking hammer, striking pin in working condition Marked as "Exhibit-"A" and loaded (ii) One live ammunition marked as Exhibit-"B". He exclusively possessed improvised fire arm and live ammunition illegally. On demand he failed to produce any document in support the said improvised fire arm and live ammunition which has been found from his possession. On further interrogation he state that he came to Mahananda Barriage under New Jalpaiguri PS, Dist- Jalpaiguri to deliver the same to his design customer for his wrongful gain. Thus when his involvement in carrying and possessing illegal fire arm and live ammunition was established, I seized that improvised loded fire arms and 01 (One) rounds of live ammunition and under proper seizure list duly signed by him as well as by available witnesses. The whole processes of seizure and labelled was made in between 1645 hrs to 1725 hrs on 27.06.2023. Accordingly, I, arrested both the apprehended accused persons after issuing memo of arrest informing him about the ground of arrest.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused person namely Sankar Adhikari (26) s/o Lt. Sunil Adhikari of Kachakali, PS- Chopra, Dist- Uttar Dinajpur is desperate and dangerous in nature, as he was carrying the said fire arm and ammunition with an objective to deliver the same to his design customer.

As he had willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Sankar Adhikari (26) s/o Lt. Sunil Adhikari of Kachakali, PS- Chopra, Dist- Uttar Dinajpur and others under appropriate section of law and arrange for its investigation.
