With due respect and humble submission I, SI Uday Sankar Mandal of Panitanki TOP-I, under Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against one escaped PC. remand accused person namely Sanjay Singh (Male - 19 Yrs) S/O- Late Dinesh Singh of Lower patty, Gurung Busty, Ward No.03, PS- Pradhan Nagar, Dist- Darjeeling in c/w Siliguri PS case no. 455/23 dated 13.06.23 U/S 380 IPC, to the effect that today on 27.06.2023, I was detailed for Panitanki TOP-I under Siliguri PS, evening table duty from 14.00 hrs to 22.00 hrs during the duty at around 15.00 hrs ASI Surojit Mallick along with K-28 Morning Mobile van force came at Panitanki TOP-I and brought one PC. remand accused person namely Sanjay Singh (Male - 19 Yrs) S/O- Late Dinesh Singh of Lower patty, Gurung Busty, Ward No.03, PS- Pradhan Nagar, Dist- Darjeeling from Siliguri PS, custody for interrogation by the IO. ASI Ratan Kr Ghosh vide Panitanki TOP-I GDE No 610 Dtd, 27.06.2023, CV 1007 Jiten Roy was detail for PC accused guard duty. At around 18.35 hrs I was engaged in my table duty and at that time CV/1007 Jiten Roy informed me that PC. accused Sanjay Singh 19 yrs was fled away from Lawful custody and escaped by jumping the boundary wall. After searching every possible places he could not traced out. This refers Panitanki TOP-I GDE No 611 Dated 27.06.2023.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the escaped PC. accused person namely Sanjay Singh (Male - 19 Yrs) S/O- Late Dinesh Singh of Lower patty, Gurung Busty, Ward No.03, PS- Pradhan Nagar, Dist- Darjeeling c/w Siliguri PS case no. 455/23 dated 13.06.23 U/S 380 IPC under proper section of law and arrange for its investigation.
