In producing herewith 05 (five) arrested person namely [1] Md. Naz, S/o- Md. Ashraf of Tikiya Para, Majdur Colony, W/No.26, Ps- Siliguri, Dist- Darjeeling. (Paddler of Toto (E-rickshaw), having without number, Blue Colour). [2] Apu Roy, S/O- Jiten Roy of Rajib Nagar, W/No.46, Ps- Pradhan Nagar, Dist- Darjeeling (Paddler of Toto (E-rickshaw), having number plate no.WB73F-5158, Red Colour). [3] Raju Mahato, S/O- Lt. Ram Prabhesh Mahato of Rajib Nagar, W/No.46, Ps- Pradhan Nagar, Dist- Darjeeling (Paddler of Toto (E-rickshaw), having without number, Red Colour). [4] Md. Firoz, S/O- Lt. Md. Najir of Matangini Colony, Tikiya Para, W/No.28, Ps- Siliguri, Dist- Darjeeling (Paddler of Toto (E-rickshaw), having without number, Red Colour). [5] Md. Wasim, S/o- Md. Munajim of Rajib Nagar, Darjeeling More, W/No.46, Ps- Pradhan Nagar, Dist- Darjeeling (Paddler of Toto (E-rickshaw), having number plate no.WB73G-1254, White Colour) along with their Toto under seizer, I SI. Arindam Chatterjee of Junction Traffic Guard, Siliguri Police Commissionerate do here by lodge written complaint against him to the effect that, on 27.06.2023 I along with C-871 Amit Oraon and CV-580 Basant Munda while performing traffic regulation duty at NH-10, near Darjeeling More, Ps- Pradhan Nagar, Dist- Darjeeling found that, the above noted persons were plying their Totos (E-rickshaws), as noted above on NH-10 by violating Govt. Order vide **Notification number 1526/1(1)/-WT/3M-56/13/PT.II Dated-27.04.2015 of Principal Secretary to the Govt. of West Bengal** and also disrupting the free flow of traffic by stopping here and there disorderly for collect passengers.

Accordingly, I along with force apprehended them and on asking they could not produce any valid documents nor could able to express any satisfactory reason to do like so. Further asking they stated their name and address as noted above.

Finding no any alternative way I arrested them u/s 41 Cr. P.C and seized their Totos form their respective possession u/s 102 Cr. P.C by preparing proper arrest memo and seizure list and brought them to Pradhan Nagar Police Station for custody.

I, therefore pray before your kindness that, kindly lodge a specific case in proper section of law against them for violating Govt. order and obstructing for free flow traffic movement and arrange for its proper investigation.
