Sub: FIR against Pilferage of Electricity

Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mr. Pradip Roy, S/O- Shanti Ranjan Roy, Resident of Ghogomali Main Road, Ward No.: 37, P.O.- Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402679346), has committed Theft of Electricity under section: 135(i)(a) & 138(b) & 135(i)(e) of the Electricity Act, 2003, read with further amendments for the Domestic as well as Commercial purpose as stated here under.

On 28.06.2023 at about 14:20 Hours, I, Sri Sourav Paul, AE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Amarasish Mohandeo, DE (E) & 2. Mr. Pranab Sikdar, Special Officer, attached with S&LP unit, Darjeeling Region Office, WBSEDCL & 3. Mr. Arnab Ray, J.E.(E) (Grade-II) & 4. Mr. Sujit Mandal, Contractor Workman attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of Mr. Pradip Roy, S/O- Shanti Ranjan Roy, Resident of Ghogomali Main Road, Ward No.: 37, P.O.- Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402679346), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection it has been found that the aforesaid accused, Mr. Pradip Roy, S/O- Shanti Ranjan Roy, Resident of Ghogomali Main Road, Ward No.: 37, P.O.- Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402679346), was consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnecting the 'Deemed Disconnected' service connection having Consumer ID: 402679346 & Meter No.: BF017279 which was disconnected on 24.02.2022 due to having outstanding dues of electricity of Rs. 34,256.08 (excluding LPSC). Moreover, the last meter consumption up to which billing was raised is 3599 KWH. And, during inspection on 28.06.2023, the service connection was found 'Physically Live' & consuming electricity through meter using the Domestic Service Connection against Consumer ID: 402679346 & Meter No.: BF017279 for Domestic as well as Commercial purpose for the shop called 'Hop Electric' in the ground floor of his aforementioned domestic premises viz. using the connection for the purpose (i.e. Domestic as well as Commercial) other than for which the usage of electricity was authorized (i.e. Domestic) & the aforesaid energy meter was found 'performing normal' having last reading of 12798 KWH dated: 28.06.2023 during seizure of the meter. Thus the service connection was used in unauthorized manner & WBSEDCL incurred huge amount of loss in revenue.

As Theft was detected I immediately with the help of my Technical staff disconnected his Service Connection and seized one number Three Phase Energy Meter having SI No.: BF017279, make: Bentec, Rating: 3x240V, 5-30A, 1600 imp/unit, Mfg.: 07/2020 (L.R.: 12798 KWH) connected with some portion of Incoming & Outgoing wires which have been used for Unauthorized reconnection of the 'Deemed Disconnected' service connection (Consumer ID: 402679346) & consuming electricity dishonestly in unauthorized manner for the purpose (i.e. Domestic as well as Commercial) other than for which the usage of electricity was authorized (i.e. Domestic) at the aforementioned Domestic as well as Commercial premises for the Domestic as well as Commercial purposes under a proper seizure list as well as the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & Witnesses & Witness of the Accused Person (i.e. Son). And, Copies of Notice, Inspection Note & Seizure List were handed over to the witness of the accused person (i.e. Son) at the inspection spot. The inspection team members left the aforesaid premises at 15:00 Hours on the same day after observing all formalities.

So the accused Mr. Pradip Roy, S/O- Shanti Ranjan Roy, Resident of Ghogomali Main Road, Ward No.: 37, P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402679346), has committed Theft of Electricity under section: 135(i) (a) & 138(b) & 135(i) (e) of the Electricity Act, 2003, read with further amendments for the Domestic as well as Commercial purpose.

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
