Sub: - Written complaint against 01(one) Driver of plying illegally on Sevoke Road without any valid documents causing obstruction to public way.

Sir,

I SI Jayanta Kr. Ray of Panitanki Traffic Guard, SPC beg to lodge a written complaint on 28.06.23 around 15.05 hrs, while on duty at Panitanki more found one (1) TOTO without registration number stationed near Panitanki More, Sevoke road in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Salam Mia (24yrs) S/O Rabu Mia- of Kali Nagar P.O Haiderpara, PS-Bosto Nagar, Dist- Malda P/A Fuleswari, PS-Bhaktinagar, Dist- Jalpaiguri. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above mentioned person (TOTO Driver) under proper section of law from your end.
