Respected Sir,

With deep regret, I cannot but inform you that a case
of theft was committed in my shop midnight last night of
10th June, '23. The burglar who was armed with a knife (as
seen in CCTV footage) broke into the shop by cutting and displacing
a welded Tin wall and left with chocolates, perfumes, therm-
flasks and other sundry goods amounting to Rs about
30,000/- (thirty thousand only) including a cash of around 2000/-
(two thousand only) after more than an hour's operation.

Under the circumstances, I shall appeal to you
to register my case and take suitable measures to
nab the culprits and recover the stolen articles and cash.
