With due respect and humble submission I the undersigned states the following few lines for your kind consideration and favourable attention, please.

02. Sir, I Apurba Singh S/O Late Ashok Singh presently the residence of Vivekananda Pally, P.O- Kadamtala & P.S. Matigara, Distt- Darjeeling, West Bengal Pin No.734011 and my permanent address is Village+P.O-Alugram, PS-Bharatpur, Distt- Murshidabad, West Bengal-742301. Presently I am serving on BSF Under Kadamtala FTR HQ NB for this reason I have stayed in my elder sister's house.

03. On 24/06/2023 at about 17:30 hrs my electric cycle was not found in Siri room from my sister's house which one I used frequently basis and value of this electric cycle is Rs. 30,000/- (Thirty thousand only). After checked/seen of CCTV Camara footage (Installed at front gate of the house) I know that "My electric cycle was theft from my sister's house by one unknown person at about 14:03 hrs as per CCTV footage which is enclosed as evidence of theft (01 No of CD).

04. During Jan'2023 to June'2023 such type of incidents occurred in multiple houses in the area of Vivekananda pally.

05. So, I therefore requested to you kindly lodge FIR against the accused which is mentioned in CCTV footage as well as return back my electric cycle as soon as possible and punishable for theft under the IPC.
