Sir,

I SI Prakash Saha of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 29.06.23 around 12.45 hrs, while on duty at 9/10 Hotel Crossing found one (1) TOTO without any registration number stationed near 9/10 Hotel Crossing, Sevoke road in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Bipul Nath S/O Sushil Nath of Baghajatin Colony, W/No.02, Siliguri, P.S-Pradhannagar, Darjeeling. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
