Sub: Written complaint against three unknown miscreant.

Sir,

I Manpreet Singh Bhatia S/O Sri. Gurdeep Singh Bhatia of Uttarayan, Under P/S Matigara Siliguri, Dist. Darjeeling would like to draw your kind attention to the following that Today at around 9.30 PM, I was coming back from my Showroom located at Saktigarh road No.10 under P.S N.J.P Dist, Jalpaiguri with my Honda city car, being TC no. WB 74 TC022/2 which was purchased yesterday in the name of my wife, Tarundeep Bhatia. When I reached near Jalpaimore under P.S Siliguri Dist. Darjeeling, the aforesaid three miscreants stopped my vehicle and knocked at the driver side window and asked money from me but when I denied the same then one out of the three miscreants broke the windshield of my vehicle and the three miscreants conjointly started assaulting me, tore the buttons of my shirt and snatched my money amounting Rs.15,000 from my right pocket and from this incident I am suffering from mental and physical agony and trauma, and they were also holding sharp cutting weapon with them giving death threats, then some local people gathered there and somehow I was able to call 100 dial for which the police reached there, then the aforesaid three person tried to run away from the place of incident but the local people caught the two miscreants but one fled away from there.

In view of above you are requested to take proper legal steps against the miscreants as per Law.
