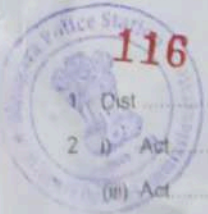

It is stated that by the said order dated; 27.02.2006, the Court of the Learned Civil Judge [Junior Division], Siliguri has been pleased to pass an order of injunction against the defendants/ops including Smt. Reba Dey, Wife of Sri Reba Dey and restrained them from encroaching the suit properties, mentioned in schedule "A" and "B" of the plain and also from dispossessing the plaintiff/petitioner from the suit properties and also from causing any interference and/or disturbances with the peaceful possession and enjoyment of the plaintiff/petitioner, that is myself in respect of the said properties and also restrained them from entering into the suit land and to change the nature and character of the suit properties described in schedule "A" and "B" of the plaint till disposal of the suit. It is stated that the said suit is still pending for hearing and disposal and the next date of which is fixed on 01.07.2023 for evidences.

Sir, today on 28.06.2023 at about 4.00 PM, one Sri Partha Pratim Dey, Son of Smt. Reba Dey and Sri Dilip Kumar Dey [Husband of Smt. Reba Dey], both are resident of Hakimpara, Post office and Police Station : Siliguri, District Darjeeling [West Bengal] and also in collusion with their associates and antisocial elements namely Sri Gopal Debnath and Sri Bikash Debnath, Both of Kawakhali and several other 10/12 anti social persons/musclemen, knowing fully about the said order of injunction, forcefully entered in my said plots of land with an intention to encroach upon a portion of my said plots of land together with bamboo khunti and GI wire, against which the said Learned Court has passed an order of injunction on 27.06.2006. And when I along with my other family members protested to obstruct them from encroaching upon my said plots of land, then they become furious and abused me and my family members and also assaulted me and wife Smt. Usha Rani Roy and outraged her modesty and threatened me and my family members with dire consequences to fulfill their illegal desire. On my/our vehement protest, they could not succeed to encroach upon the said plots of land and ultimately fled away by taking their said bamboo khunti and GI Wire. I can identify all the said anti social persons, if produced before me. They have committed the offence punishable under the law. I have verbally reported the matter to the Police Station at the said time and police visited the spot.

So, I requests your good office to be kind enough to take a note of the above in your record and book the said persons for investigation into the matter and arrange to punish the culprits as per law.
