This is to inform you that today morning around 3.53 am about seven to ten people entered our showroom by jumping the fence, threatened the guard by showing sharp weapons, and forced to open the gate.

They asked for the location of the cash, but the guards denied, they took the guards inside the showroom & tied and assaulted them. After this they located the cash counter, they break open the door lock of the cash counter and then the cash vault cabinet. They could not open the cash vault so they took away the cash vault and accessories from our showroom. There was around Rs. 23,65,000/- (Rupees Twenty three lakhs sixty five thousand only) cash in the cash vault. After that they escaped the showroom in the way they entered the showroom.

Kindly register an FIR against this dacoity and do the needful.
